Preface

The Association Européenne d'Etudes Juridiques et Fiscales was founded in 1957 to bring together lawyers from each Member State of the European Community who are practising in the field of business law.

The present membership of 55 includes mainly lawyers in private practice, but also in-house counsel with industrial enterprises and banks, as well as the Commission and the Council of the European Community.

The present book has developed from the Association's first publication, *Branches and Subsidiaries in the European Common Market* which in the Sixties was also published in French, German and Dutch. In 1982 *Branches and Subsidiaries* was extended to cover more subjects and more countries, and given the title *Business Law in Europe*. The accession of Spain and Portugal and new legislation necessitated up-dating of the book. Faced with the constant stream of new legislation and caselaw in the fields covered by this book the Association decided that the only way to maintain the value of it was to make it a loose-leaf edition.

The second publication under the auspices of the Association is *Product Liability in Europe*, published by Kluwer-Harrap in 1975. This book contained the reports for the first international conference in Europe on that subject held in Amsterdam and organised by the Association.

The third publication, *Security on Movable Property and Receivables in Europe*, also served as a preparation for a conference sponsored by the Association. It was held in London in March 1988. The book was published by ESC Publishing Limited in Oxford.

With this new edition of *Business Law in Europe* the Association continues its endeavours to provide the international legal and business communities with easily accessible, succinct and yet accurate information on issues of practical importance for those who are involved in doing business on a European scale.

Some Terms and Abbreviations

Although we are well aware of the impossibility of adequately translating many legal terms into English we have endeavoured to achieve some uniformity of terminology throughout this book. To this end we have generally followed the terminology of the English versions of official documents of the EC.

The English and Irish authors have of course used their own terms. For an explanation of some terms of European law we refer to the chapter on Some Observations on the Law of the European Communities. A short explanation of some of the other terms may be useful.

- Enterprise = undertaking or business
- Public company is used for the equivalent of société anonyme (SA),
