PREFACE

Thirty-four years ago the editorship of the Textbook of Pediatrics, which had been earlier edited by Griffith and Mitchell, was assumed as an obligation of friendship by Waldo E. Nelson after the death of A. Graeme Mitchell. The Fourth and subsequent editions, first as "Mitchell-Nelson" and then as "Nelson," have thrived, with the indispensable help of a host of contributors and under the gifted leadership and editorial direction of Dr. Nelson.

It is with some trepidation and a sense of somewhat awesome responsibility that we have taken on the job of editing the Tenth edition of the Nelson Textbook of Pediatrics.
