Mapping African America

History, Narrative Formation, and the Production of Knowledge

The world of African America extends throughout the northern, central, southern and insular parts of the American continent. The essays included in this volume take the creation of that world as a single object of study, tracing significant routes and contacts, building comparisons and contrasts. They thus participate in the reworking of traditional approaches to the study of history, the critique of literature and culture, and the production of knowledge. All are engaged in an effort to locate the African American experience within a wider pan-African vision that links the colonial with the postcolonial, the past with the present, the African with the Western.

Mapping African America sketches lines that, far from limiting our geography, extend our knowledge of the Africanist influence on and their participation in what is generally called "Western" culture. This creative challenge to traditional disciplines will not only enhance the reader's understanding of African American Studies but will also help forge links with other academic fields of inquiry.

Liberating Narratives

The Authorization of Black Female Voices in African American Women Writers' Novels of Slavery

Three contemporary novels of slavery – Margaret Walker's *Jubilee* (1966), Sherley Anne Williams's *Dessa Rose* (1986) and Toni Morrison's *Beloved* (1987) – are the central focus of *Liberating Narratives*. In significantly different ways that reflect their individual and socio-political contexts of origin, these three novels can all be read as critiques of historical representation and as alternative spaces for remembrance – 'sites of memory' – that attempt to shift the conceptual ground on which our knowledge of the past is based.

Within a theoretical framework informed by recent black feminist and narratological discussions, the study analyses in particular the textual strategies that Walker, Williams and Morrison use to conceptualize and authorize these liberatory imaginative spaces – spaces in which African

American women become central historical agents. It shows how revisionary shifts in thematic emphasis require careful reconsiderations of a literary text's formal organization to allow for the representation of a 'free' black and female subject.

Paradise Reconsidered

Toni Morrison's (Hi)stories and Truths

Toni Morrison's *Paradise* (1998) arrived on the scene amid vociferous acclaim and much consternation. Third in the trilogy begun with *Beloved* and *Jazz*, this fascinating yet complicated the novel has sown as much confusion as admiration. How does it work? How does the novel close the trilogy? Indeed, a major complaint among reviewers, why does Morrison overload us with so many characters and stories?

In this first book-length study of *Paradise*, Justin Tally securely links the work to Morrison's entire oeuvre and effectively argues that while all of the novels of the trilogy are deeply analytical of the relationship of memory, story and history, the historical narrative: memory is fickle, story is unreliable, and history is subject to manipulation. A master narrative of the past is again dictated by the dominant discourse, but this time the control exerted is black and male, not white and male. Though this stranglehold threatens to deaden life and put the future on hold, Morrison's narrative disruptions challenge the very nature of this "paradise" on earth.

With these considerations, "*Paradise*" *Reconsidered* locates the author at the center of the on-going literary and cultural debates of the late 20th century: the postmodern discussion of history, particularly Afro-centrist history, the production of knowledge, the class divisions that are shattering the black community, and questions of "race" and essentialism. What does it mean to be "black"? And who is the white girl anyway? A learned and at the same time accessible early reading of a highly complex novel. Black Liberation in the Americas

The recognition that Africans in the Americas have also been subjects of their destiny rather than merely passive objects of European oppression represents one of the major shifts in twentieth-century mainstream historiography. Yet even in the eighteenth and nineteenth centuries, slave narratives and abolitionist tracts offered testimony to various ways in which Africans struggled against slavery, from outright revolt to day-to-day resistance. In the first decades of the twentieth century, African American historians like Carter G. Woodson and W.E.B. Du Bois started to articulate a vision of African American history that emphasized survival and resistance rather than victimization and oppression. This volume seeks to address these and other issues in black liberation from interdisciplinary and comparative perspectives, focusing on such issues as slave revolts, day-to-day resistance, abolitionist movements, maroon societies, the historiography of resistance, the literature of resistance, black liberation movements in the twentieth century, and black liberation and post colonial theory. The chapters span the disciplines of history, literature, anthropology, folklore, film, music, architecture, and art, drawing on the black experience of

liberation in the United States, the Caribbean, and Latin America.

The Story of Jazz

Toni Morrison's Dialogic Imagination

Ever since its publication in 1992, *Jazz*, probably Toni Morrison's most difficult novel to date, has elicited a wide array of critical response. Many of these analyses, while both thoughtful and thought-provoking, have provided only partial or inherently inconclusive interpretations. The title, and certain of the author's own pronouncements, have led other critics to focus on the music itself, both as medium and aesthetic support for the narration. Choosing an entirely different approach for *The Story of Jazz*, Justine Tally further develops her hypothesis, first elaborated in her study of *Paradise*, that the Morrison trilogy is undergirded by the relationship of history, memory and story, and discusses "jazz" not as the music, but as a metaphor for language and storytelling. Taking her cue from the author's epigraph for the novel, she discusses the relevance of storytelling to contemporary critics in many different fields, explains Morrison's choice of the hard-boiled detective *genre* as a ghost-text for her novel, and guides the reader through the intricacies of Bakhtinian theory in order to elucidate and ground her interpretation of this important text, finally entering into a chapter-by-chapter analysis of the novel which leads to a surprising conclusion.

Landschafts- und Bewußtseinsdarstellung in australischen Romanen des 20. Jahrhunderts Die Untersuchung australischer Romane lädt zu einer Reise durch literarische Landschaften ein. Sie beginnt zur Jahrhundertwende mit Joseph Furphy als frühem Vertreter des modernen Romans und zeigt eine Entwicklung auf, die schließlich in der Auflösung realer Landschaften in eine *Psychogeographie* bei Gerald Murnane gipfelt.

Mentale Prozesse sind Filterinstanzen, die zwischen die Landschaft und ihre literarische Umsetzung treten. Die literarische Umsetzung dieser 'Filter' wird analysiert, um ein umfassendes Erklärungsmodell für die kominierende Buschbildungskultur in der Literatur Australiens, die bis heute fortwirkt, zu entwerfen. Das Stereotyp des menschenfeindlichen *Outback* erweist sich als Frustration der perzipierenden Figur, die eine an britische Konventionen geprägte Bewußtseinshaltung auf die Natur projiziert. Diese mentale Haltung ist den Naturgegebenheiten Australiens unangemessen.

Dabei ermöglicht die breite Auswahl von Romanen die Ableitung einer historische Stufenfolge, bei der sich im Verhältnis von Protagonist und Landschaft eine zunehmende Bewußtseinsdomianz herauskristallisiert. Die Untersuchung liefert daher einen wichtigen Beitrag zur australischen Literaturgeschichte und stellt ein Stufenmodell als Analyserahmen für die (post-)moderne Romanentwicklung vor.

Dieses Buch untersucht sechs von Shakespeares frühen Komödien (*The Taming of the Shrew*, *A Midsummer Night's Dream*, *The Merchant over Venice*, *Much Ado about Nothing*, *As You Like It* und *Twelfth Night*) im Hinblick auf die Beziehungsstrukturen zwischen den Dramencharakteren. Das methodische Instrumentarium geht auf Watzlawick et al., *The Pragmatics of Human Communication* zurück. Zentrale Aspekte der Analyse sind u. a. das Spannungsverhältnis zwischen der Inhalts- und Beziehungsebene der Kommunikation, zwischen verbaler und non-verbaler Kommunikation (z. B. der Einsatz von Körpersprache, von Requisiten und Kostümen im Schauspiel) und zwischen Beziehungen, die auf Gleichheit, und solchen, die auf Ungleichheit beruhen.

Die Namen in Edmund Spensers Versepos

The Faerie Queene: Immortal Name,
Memorable Name, *Well-becoming Name*

Zu den auffälligen Merkmalen von Edmund Spensers Versepos *The Faerie Queene* gehören die offensichtlich bedeutungsvollen Namen. Viele von ihnen sind leicht zu entschlüsseln, aber damit beginnt ihre Faszination erst. Die Namen erfüllen die unterschiedlichsten Funktionen im Text: Sie tragen bei zur Charakterisierung von Figuren und Orten und untermauern die Atmosphäre von Situationen. Sie verbinden und kontrastieren Figuren und bauen Spannungsfelder zwischen der Bedeutung eines Namens und den Namenträgern

auf. Spenser folgt nicht dogmatisch einem philosophischen Konzept der Bedeutung von Namen, sondern setzt die Namen je nach Bedarf ein, sowohl für allegorische Sinngebung als auch zur Schaffung von Komik.

Aufbauend auf einer neu entwickelten Typologie der Bedeutungskonstitution durch Namen in literarischen Texten, konzentriert sich die vorliegende Untersuchung der Namen in *The Faerie Queene* dementsprechend weniger auf die etymologische Bedeutung von Namen als vielmehr auf das Wechselspiel von Namen und Bedeutungen im Text. So kann anhand von Hauptfiguren wie dem Redcrosse Knight, Una und Guyon gezeigt werden, daß die Deutung der Namen neue und fesselnde Ansätze zur Interpretation bietet.

In den (höfischen) Festen der Renaissance und des frühen Barock kam der Architektur – etwa von Triumphbögen und Saaleinrichtungen oder Proszessionsbögen, aber auch der in Bühnenbildern dargestellten Architektur – eminenti Bedeutung zu, bei der Definition des festlichen Repräsentationsraumes und als Bedeutungsträger. Majestic Milton

British Imperial Expansion and Transformations of *Paradise Lost*, 1667–1837

This study investigates how Milton's texts, above all *Paradise Lost*, were read in the context of eighteenth- and early-nineteenth-century British empire building. Milton's epic was implicated in the articulation and criticism of early modern colonialist discourse; it also lent itself easily to later imperial and anti-imperial appropriations. Milton the 'national poet' emerged from the strife between Whigs and Tories for his legacy; this book analyses Milton's presence in a number of discourses that are characteristic of the Whig model of secular history: the discourses about empire, language and literary criticism, travelling and astronomy, agriculture, commerce and *Pax Britannica*, as well as the slave-trade. The temporal frame extends from the Restoration through the loss of the American colonies to the Second British Empire and 'Milton in India'. Eighteenth-century British national epics, commented Milton editions and poetic Milton recreations invented a tradition for the British Empire and reintroduced the Virgilian concept of *translatio imperii*, transforming Milton's allegories of divine power into descriptions of secular authority. This study contextualizes traditional stories about 'Milton and Romanticism' by examining mostly 'minor' writers; still, Dryden, Johnson, Pope and Blake feature in some detail. The epilogue shows that even postcolonial rewritings of Milton make more sense in the light of the eighteenth-century Milton and his presence in the nineteenth-century British colonial education syllabus.



Introduction to the Second Edition

We are happy and proud to see this second edition of the first volume of our series Contributions to Asian American Literary Studies reach the literary market. The success of the first edition proves that there is interest for this kind of scholarship and encourages us to expand the series and add new volumes to Contributions to Asian American Literary Studies—we are proud that two more volumes have appeared in the series in 2004. We continue to anticipate more volumes in the coming years.

Our gratitude for this success goes to our publisher, Mr. Veit Hopf of LIT Verlag, and of course to our contributors, whose quality work made this success possible. We also want to thank again our cover designer, Ruedi Ammann, who makes us look good and whose artwork has made the production of these books more pleasurable.

Responses to the volume have allowed us to rethink our project, which has led us to work actively with the new contributors in order to produce dynamic and groundbreaking work. Our reviewers have been kind with praise, especially for the articles on poetry. They have also lauded our concern for a truly international approach that tries to locate itself apart yet in dialogue with the U.S. American paradigms of the discipline. Thus Monica Chiu has observed “many of the essays’ overt challenge to accepted, even canonized, texts and U.S.-generated readings of Asian American literature.” And Mita Banerjee liked the subdividing of the collection “along thematic lines rather than with regard to critics’ national locations,” which creates “an international discourse of Asian American scholarship” and “a constructive dialogue of scholars.” Taking as an example Kirsten Twelbeck’s essay on *DICTEE* and her opposition against any “cultural ownership” of that text, however, Banerjee warns that our approach may encourage a somewhat decontextualizing vision of Asian American studies which may elide some necessary responsibility towards a particular text’s minority context. We agree that this issue must be responsibly negotiated yet are at the same time happy to see that our “act of opening up” is understood as such and appreciated.

In any case, these are precisely the terms of the dialogue we aimed to create among U.S. and international scholars of Asian American literature. The diverse approaches we can offer stem from both solid scholarship into the specificities of ethnic writing as well as from the wider perspective that comes from critical

locations outside (but not ignorant of) the accepted discourse of U.S. academe. The two years that have passed since the first volume was published has also seen the emergence of new critical perspectives on Asian American writing, many of which are increasingly plural in their approaches. We believe that our work has contributed to this plurality and the multiplicity of positions from which to read ethnic writing. A plurality of ideas, positions, and perspectives can only enhance the future of Asian American critical studies. We hope this series continues to do precisely that.

Introduction: Asian American Literature in the International Context

Rocío G. Davis and Sämi Ludwig

Since the publication of Maxine Hong Kingston's *The Woman Warrior* a quarter of a century ago, we have witnessed an unprecedented growth in the literatures of Asian America, both in their creative expression and in the substantial body of criticism that seeks to discuss them in the light of contemporary identity and cultural politics. Kingston's emblematic text not only opened the way for writers to engage the complexities of their ethnicity, but also signaled a narrative boldness and maturity regarding the appropriation and subversion of traditional genres. The range of writing that comprises today's expanding Asian American canon includes the works of authors who continue Kingston's experimentation with and exploration of genre and theme, the borders between fiction and reality, issues of intercultural expression and identity, and the question of authenticity. Asian American writing has tremendously expanded its range of expression—be it in its experimental edge, as literary technique, or in the further integration of elements from its ever more diverse and complex ethnic constituencies. More and more different experiences, stories, and thematic issues are finding literary expression in innovative forms that range from words to performance. Today the cultural production of Asian America has a scope and variety that is as aesthetically complex and sophisticated as any other literature, yet maintaining a very particular flavor of its own.

Asian American literature offers a very rich field of investigation because in it we comprehend transcultural literary phenomena beyond geographic, national, ethnic, and even linguistic boundaries. Recent scholarship consistently points to the need to expand and deepen the approaches to this complex set of concerns and strategies. Shirley Lim believes that Asian American literature

as a heuristic term is the mountain of gold to be mined by archival and scholarly labor. But as a distinct minority literature, it has become a space for cultural contestation between forces for containment and enlargement. Places under interrogation are the nature and boundaries of this body of materials, its categorization and composition, and the interpretations and evaluations brought to bear on it. (149)
