
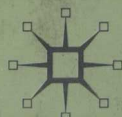

Notes on the Contributors

Dr Alfred Baird is Head of the Maritime Research Group at Napier University's Transport Research Institute (TRI) in Edinburgh. Prior to his academic career he worked for a liner shipping company, followed by a position as shipping manager in a manufacturing company. He has researched, published and taught in a number of areas in maritime transport, covering issues such as port competition and privatization, strategic management in shipping, market analysis in the shipping and ports industry, shipping cost modelling, and assessing the feasibility of new shipping services and associated port developments.
