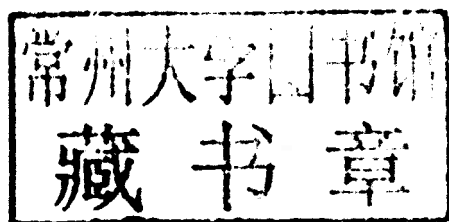

Alberto Alemanno is the Jean Monnet Professor of EU Law and Risk Regulation at HEC Paris, Global Clinical Professor at NYU Law School, where he is the faculty director of the HEC–NYU EU Regulatory Policy Clinical program, and Adjunct Professor at Georgetown Law. Alberto was formerly *référéndaire* (clerk) at the Court of Justice of the European Union, Teaching Assistant at the College of Europe in Bruges and attorney at law in New York. He is the author of *Trade in Food: Regulatory and Judicial Approaches in the EU and the WTO* (Cameron May, 2007), editor of *Governing Disasters: The Challenges of Emergency Risk Regulation* (Edward Elgar, 2011), co-editor of *Better Business Regulation in a Risk Society* (Springer, 2013) and *Foundations of EU Food Law & Policy* (Ashgate, 2013). Together with Amandine Garde, he is editing *Regulating Lifestyle Risks: Europe, Alcohol, Tobacco and Unhealthy Diets* (Cambridge University Press, 2014). Amandine Garde is a Professor in the School of Law and Social Justice, University of Liverpool, UK. Before joining the university in April 2013, she lectured at King's College London, the Faculty of Law in Cambridge (where she was also a Fellow of Selwyn College), the University of Exeter, and the University of Durham. Her research interests lie in the fields of European Union trade, consumer, advertising, food and public health law. She specialises more specifically in the role legal instruments can play in improving public health and the wellbeing of children as a group of particularly vulnerable consumers. Her book *EU Law and Obesity Prevention* is the first to offer a critical analysis of the obesity prevention strategy of the European Union. She recently won a grant from the Economic and Social Research Council to continue her work on the regulation of food marketing to children. She has spent part of her research leave at the World Health Organization and has provided technical assistance to several States and regions worldwide in the implementation of the WHO Recommendations on food marketing to children. Rachel holds a Bachelor of Laws degree from the University of Nairobi and has nine years' experience in tobacco control ranging from drafting and lobbying for tobacco control legislation in Kenya, working on enforcement campaigns of tobacco control legislation in Kenya, and training government enforcement officers and media advocacy to create awareness about the dangers of tobacco use and the contents of tobacco control legislation. She has also served as *amicus curiae* in two court cases filed by the tobacco industry challenging the Kenyan tobacco control legislation. Under the African Tobacco Control Consortium, Rachel works with six staff and grantees in ten countries in sub-Saharan Africa to support national and regional advocacy campaigns for the implementation of the Framework Convention on Tobacco Control in sub-Saharan Africa. In recognition of her work at national and regional level, in 2009 Rachel was awarded the Judy Wilkenfeld Award for International Tobacco Control Excellence by the Campaign for Tobacco Free Kids based in Washington, DC.

Jonathan Liberman is Director of the McCabe Centre for Law and Cancer, Australia, a joint initiative of Cancer Council Victoria and the Union for International Cancer Control ('UICC'), engaged in research, policy development and advocacy on the role of law in the prevention and treatment of cancer. Jonathan has over a decade of experience in legal and policy research, advice and advocacy on issues relating to cancer prevention and treatment at both domestic and global levels. His work has covered a wide range of issues across tobacco, alcohol and food regulation, access to medicines,

international trade law, international investment law, international drug control law and international human rights law. He is a member of the Australian Government's Expert Advisory Group on Plain Packaging of Tobacco Products and the Standing Committee on Tobacco to the Intergovernmental Committee on Drugs. Benn McGrady is Project Director of the Initiative on Trade, Investment and Health and Adjunct Professor at the O'Neill Institute for National and Global Health Law, Georgetown University Law Center. He is the author of *Trade and Public Health: The WTO, Tobacco, Alcohol and Diet* (Cambridge University Press, 2011). Benn teaches courses exploring the intersection between trade and investment agreements and health at Georgetown and advises governmental, inter-governmental and non-governmental bodies on these issues.
