## The Authors



John B. Oakley is Distinguished Professor of Law at the University of California at Davis. From 1991 to 1996, by appointment of the Chief Justice of the United States, he served as the Reporter for the United States Judicial Conference's Committee on Federal-State Jurisdiction. From 1997 to 2001, by appointment of the Chief Justice of California, he was a member of the State of California's Appellate Process Task Force. From 1996 to 1998, Professor Oakley was a member of the Board of Directors of the American Judicature Society. In 2006-2007, he chaired the system-wide Academic Senate of the University of California.

Professor Oakley received his B.A. in History from the University of California at Berkeley in 1969, with Honors and with Distinction, and his J.D. from Yale University in 1972, where he served as an editor of the *Yale Law Journal* and, in his final year, as an Assistant in Instruction. Before joining the Davis Faculty in 1975, he served for one year as a law clerk for the Chief Judge of the US District Court for the District of Connecticut, and for two years as a law clerk for the Chief Justice of the California Supreme Court. In 1979-1980, he was the Scholar in Residence in the Civil Rights Division of the US Department of Justice, in Washington, DC, participating in litigation across the United States as a Senior Trial Attorney. In 1982-1983, he was a visiting scholar at University College, Oxford. From 1984 to 1996, he served by appointment of the California Supreme Court as appellate counsel for a condemned California prisoner. Professor Oakley remains an active member of the State Bar of California who often serves as a consultant on matters of jurisdiction and procedure to lawyers conducting complex civil litigation in state and federal courts throughout the United States. From 1994 to 2004, he served as Reporter for the American Law Institute's Federal Judicial Code Revision Project. He has taught as a Visiting Professor at the University of California, Berkeley, and at the University of Tennessee. In 2005, he was given the title Distinguished Professor of Law by the University of California, Davis.
