## How to use the Digest

### THE DIGEST

The Digest is now wholly green band. As well as the main text volumes, the Consolidated Tables, Consolidated Index volumes and this Supplement, there are four Continuation Volumes: D, covering cases and supplementary material 1971–75; E, 1976–79; F, 1980–83; and G, 1984–85.

### THE SUPPLEMENT

The purpose of the Supplement is to keep The Digest up to date. It does this by:

1. Extending the Consolidated Table of Cases from the date of publication to the present;
2. Indicating where the text of the various titles has been amended or changed by subsequent cases and developments in the law.

The Supplement is cumulative. This one replaces the 1989 Supplement which may now be discarded.

### FINDING A CASE BY NAME

For cases reported prior to 1987, search the Consolidated Table of Cases. This lists the cases alphabetically, referring to the appropriate volume and title. To find the case number it will be necessary to look up the case again in the Table of Cases at the front of the relevant green band volume.

For cases reported after 1st January 1987, search the Table of Cases at the front of the Supplement. This gives a reference to the volume, subject, and case number, rather than to the volume and title.

### FINDING A CASE BY SUBJECT MATTER

Each title begins with its own Table of Contents which indicates the relevant part of the book for specific content areas. In addition, there is a Digest Consolidated Index which refers to the appropriate volume, title and case number.

Once a case has been found a quick check in the Supplement will show whether it has been annotated or otherwise developed.

### CROSS REFERENCES

Cross references are made throughout The Digest and in other works to case numbers in the replaced volumes: e.g. See TORT vol 45 (repl) no 198. Green band Reissue volumes have now taken the place of the blue band Replacement volumes. Green band 2nd Reissue volumes replace the green band Reissue volumes. New case numbers can be found by using the Reference Adaptors at the end of the volumes. The Reference Adaptors list the replaced case numbers and the reissued case numbers side by side.
