

FOREWORD

The Proposal of the European Commission recasting the Brussels I Regulation on jurisdiction and the recognition and enforcement of judgments in civil and commercial matters identifies a number of deficiencies in the Regulation's operation and submits a number of amendments to improve its operation, with a view to facilitating cross-border litigation and removing the remaining obstacles to the free movement of judgments. In short, the Proposal extends the application of the rules on jurisdiction of the Brussels I Regulation to third-country defendants, further harmonises the subsidiary jurisdiction rules through the creation of a *forum necessitatis*, gives relevance to a discretionary *lis pendens* rule for disputes before the courts in third countries, improves the effectiveness of choice-of-court agreements, outlines the interface between the Regulation and arbitration, develops the current system of coordination of legal proceedings before the courts of different Member States, and, with some exceptions, abolishes the procedure for recognition and enforcement of judgments in another Member State (*exequatur*).

The authors of this volume, including experts who directly contributed to the European legislation resulting in the Brussels I Regulation and the parallel Lugano Convention and the Proposal for its recast, examine the solutions envisaged in the Proposal in detail. Their contributions comprise the papers presented at the Milan Conference held in November 2010 entitled, *Cooperazione Italo-Tedesca nella revisione del Regolamento Bruxelles I – Deutsch-Italienische Kooperation im Rahmen der Neufassung der Brüssel I-Verordnung*.

The purpose of the conference and this volume is to discuss the primary, debated questions, which led the Commission to publish its Proposal, and to offer a contribution to the clarification and solution of these questions. The editors hope that the submitted proposals and theses can spur further discussions and contribute to the ongoing debate within the EU institutions.

The conference was held thanks to the financial sponsorship of the *Ateneo Italo-Tedesco* within the *Programma Dialoghi Italo-Tedeschi*, as well as under the patronage of the *Associazione per gli scambi culturali tra giuristi italiani e tedeschi*, the *Italian-German Chamber of Commerce* and the *Chamber of Arbitration of Milan*. They deserve our deep gratitude.
