# Preface

Once again the pace of change in this area of law (legislative and judicial) has necessitated a further edition. The Trade Union Act 1984 has made major changes since the last edition (frequently of a particularly newsworthy nature), there have been important changes by regulations, and the miners' strike of 1984/85 produced significant case law in abundance. Fortunately, we have stumbled across a period in which there is no immediately impending legislation of the importance of the 1980, 1982 and 1984 Acts (and the next election is still some way off). However, nothing stands still long enough for the authors to be able to paint an entirely static picture, and at the time of writing there are three Bills before Parliament which will eventually affect matters covered in this book. These are: the Wages Bill, which seeks to (i) repeal the Truck Acts 1831–1940 and the Payment of Wages Act 1960 and replace them with restrictions on deductions from pay, (ii) amend the law relating to Wages Councils (repealing and replacing the Wages Councils Act 1979), and (iii) abolish the redundancy rebates scheme (except in the case of small employers); the Social Security Bill, which includes provisions enabling the establishment of a scheme for the payment of Family Income Supplement through the employer ('Family Credit', on the model of Statutory Sick Pay) and provisions amending the drafting of the trade dispute disqualification for unemployment benefit; the Sex Discrimination Bill which seeks to abolish the small firm exemption, modify the private household exemption, bring within the principal Act non-binding collective agreements and employer/union/professional rules, and remove the special protection given to adult women in relation to hours of work. Most of these changes are adverted to in the text as proposals, the Bills themselves not having been available at the time of writing. In addition, there have been consultative papers on reforms to the industrial injuries scheme and on proposals to make the statutory maternity allowance payable through the employer.

One innovation in this edition is detailed cross referencing to *Harvey on Industrial Relations and Employment Law*, the aim being to allow the reader to pursue a particular point in far greater (not to say exhaustive) detail in that work than is possible within the confines of a textbook; this is particularly

important in chapter 6, on the law and practice of unfair dismissal and redundancy.

The law is stated as at mid-February 1986.
