NANCY J. ADLER is Professor of Organizational Behavior and Cross-Cultural Management at the Faculty of Management, McGill University, Montreal. She received her BA in economics and her MBA and PhD in management all from the University of California at Los Angeles.

Dr. Adler conducts research and consults on strategic international human resource management, expatriation, women in international management, international negotiating, developing culturally synergistic approaches to problem solving, and international organization development. SHEILA M. PUFFER is Associate Professor at the College of Business Administration, Northeastern University and a fellow at the Russian Research Center, Harvard University. Professor Puffer has published 25 articles on motivation, rewards, and disciplinary action; chief executive succession; and Russian management. SUNUNTA SIENGTHAI is Associate Professor and Associate Dean at the Faculty of Commerce and Accountancy, Thammasat University Bangkok. She received her BA in English from Chulalongkorn University, and her MA and PhD in labor and industrial relations from the Institute of Labor and Industrial Relations, University of Illinois at Urbana-Champaign. Dr. Siengthai conducts and publishes her research on labor management relations and productivity, human resource management, cross-cultural management, human resource development in the ASEAN countries, labor migration, male-female earnings differentials, and public enterprise management. LORNA WRIGHT is Director of the Centre for Canada-Asia Business Relations at Queen's University, Kingston, Canada, and Associate Professor in the School of Business. She received her BA in psychology from Wilfred Laurier University, her MA in applied linguistics from the University of Essex, her MIM (masters in international management) from the American Graduate School of International Management, and her PhD in business administration from the University of

Western Ontario.
