Preface

The fourth edition of Law Books in Print is a record of books published in the English language throughout the world, in print as of December 31, 1981. Primary legal materials (e.g., statutes, court reports), looseleaf reporting services, government publications, pamphlets of less than fifty pages, juvenile works, microforms, and periodicals are excluded. Included are all other types of law books: monographs, treatises, multi-volume sets, and reprints (including government publications, if commercially reprinted). In addition to strictly legal works, many law-related titles have been included, especially in such fields as political science, business and economics, environmental affairs, and international relations. Every effort has been made to compile a complete record of books in print of a legal nature.

Grateful acknowledgement must be given to many individuals who contributed to the publication of this work. Francis Gates and James Hoover, successive Law Librarians at the Columbia University School of Law, were generous with their encouragement and in making time available for this project whenever it was necessary. Michael Crisafulli provided expert assistance in verifying publishers' names and addresses. Paul E. Peters of the Columbia University Libraries Systems Office was enormously helpful in developing an on-line input system for data storage and editing, and he provided assistance at odd hours throughout the project. Jan Miller, Manager of Systems and Operations, NASA Industrial Operations Center, University of Pittsburgh, was responsible for major changes in the way in which the data base was organized and used, and she worked constantly to insure consistency and integrity of the various files. Philip F. Cohen, President of Oceana Publications, Inc. provided constant encouragement, direction and support, and David Cohen, Executive Vice President, provided endless hours of assistance with every aspect of production. The advances made in the present edition in the use of data base technology are largely due to his efforts. Finally, this edition would have been impossible without the work done in previous editions by J. Myron Jacobstein and Meira G. Pimsleur. To Meira, especially, for her example and encouragement, I owe a debt of gratitude which words cannot express.

These volumes are presented to the professions of law and law librarianship in the hope that they will assist in the discovery and the spread of knowledge, without which all would be darkness and chaos.

How to Use Law Books in Print

This edition is based on information found in the previous edition of Law Books in Print, compiled and edited by J. Myron Jacobstein and Meira G. Pimsleur, and in the volumes of Law Books Published covering the years 1975 through 1981. In order to bring this information up to date, the data bases for these publications were merged, and lists of titles were compiled and sent directly to publishers for correction and up-dating. Every entry in Law Books in Print has been prepared with the publisher's assistance. With very few exceptions, books from publishers who did not respond to our mailings have been deleted from the list. In this way, the user is assured a bibliography which is accurate and which consists entirely of titles which are known to be in print. Every effort has been made to eliminate duplication of entries, to reconcile variants of authors' names, and to provide complete and accurate addresses for publishers.

The work consists of four lists: Author/Title, Subject, Series, and Publisher. In the Author/Title list, works appear under the names of all authors or editors and under the title in one alphabet. The Subject list consists of topical subjects subdivided by geographical names or by other subjects, and the names of organizations as subjects, all in one list. Subjects are, for the most part, traditional legal subjects which are familiar to lawyers and law librarians. The Series list includes works appearing in many series, both numbered and unnumbered. Finally, the Publisher list brings together all legal titles of the same publisher and can serve not only to ease acquisitions, but also to indicate something of the nature of a given publisher's output. Full bibliographical information is given in every entry; there is never any need to look elsewhere to complete information, once a desired title has been located. A Series Index is located in volume 5.

Each entry consists of as many of the following data elements as are relevant: author(s); title; edition; publisher; date; paging (or number of volumes); price; Library of Congress card number; International Standard Book Number; series; subject(s). Because information was obtained from publishers, L.C. card numbers do not appear as frequently as in the past; I.S.B.N.s, however, appear more frequently.

Prices for foreign publications are given in U.S. dollars if a dollar equivalent was supplied by the publisher. If no dollar equivalent was supplied, prices are in local currency. The dollar sign is used to indicate U.S. dollars; all other prices appear without an indication of currency. It was thought unwise in this era of rapidly fluctuating rates of exchange to attempt to provide U.S. dollar equivalents for all prices. Current equivalencies can easily be calculated by using the tables found in most metropolitan daily newspapers.

Entries are as complete as the information provided by publishers; where paging, price, or other information does not appear, this is because it was not supplied by the publisher of the work in question.

The Author/Title list is arranged in one alphabet. Each entry contains full bibliographical data. Numerals as the initial element in titles file at the end of the alphabet.

The Subject list is arranged alphabetically by subject and within subjects alphabetically by main entry. The undivided subject appears first, followed by the subject divided either by geography or by another subject, interfiled. For example, the order is: Taxation; Taxation - Canada; Taxation - Exemption; Taxation - Germany; etc. A Guide Subject Headings, including references, appears at the front of each volume of the Subject list.

The Series list is arranged alphabetically by series name, and within series alphabetically by main entry.

The Publisher list is arranged by publisher name, and within publisher alphabetically by main entry. Full addresses of publishers and their abbreviations as used within entries are given in a separate list, which appears in every volume.
