Bryant Keith Alexander is Professor of Performance, Pedagogy and Culture in the Department of Communication Studies at California State University Los Angeles, and currently serves as the Associate Dean of the College of Arts and Letters. His published essays have appeared in a wide variety of scholarly journals and books including: *Men and Masculinities: Critical Concepts in Sociology*, the *Handbook of Performance Studies*, the Third Edition of the *Handbook of Qualitative Research*, the *Handbook of Critical and Indigenous Methodologies*, and the *Handbook of Communication and Instruction*. He is the coeditor of *Performance Theories in Education: Pedagogy, Identity and Reform* (Erlbaum, 2008) and the author of *Performing Black Masculinity: Race, Culture and Queer Identity*.

Brenda J. Allen is a Professor of Communication and Associate Dean in the College of Liberal Arts and Sciences at the University of Colorado Denver. Judith N. Martin is Professor of Intercultural Communication in the Hugh Downs School of Human Communication at Arizona State University. Yoshitaka Miike is Associate Professor in the Department of Communication at the University of Hawai'i, Hilo. Inspired by Dr. Molefi Kete Asante's Afrocentric idea, he has proposed and developed the metatheory of Asiacentricity as an alternative paradigm for the study of Asian cultures and communication. Dreama G. Moon is Professor of Intercultural Communication in the Department of Communication at California State University, San Marcos. In her scholarly work, she is interested in the social construction of domination and the ways in which both dominant and nondominant group members negotiate, acquiesce to, and oppose domination. Her research broadly focuses on how dominant ideologies, such as white supremacy, classism, and sexism, are reproduced in and by communication as well as how they are contested, disrupted, and resisted. Her research has appeared outlets such as the *Communication Quarterly*, *Howard Journal of*
