PREFACE

This book is the result of a joint venture between the two standing commissions Commission on Corporate Acquisitions and Joint Ventures and the Insolvency Commission of the International Association of Young Lawyers (AIJA). It is based on the working session of the two commissions held during the annual congress of AIJA in Montreux in 1996. Rescue of Companies contains a general report summarizing the main differences, peculiarities and common principles of the various jurisdictions as well as the twenty-four national reports from twenty-three jurisdictions describing the law and practical experiences in these jurisdictions. Rescuing companies is becoming more and more an alternative to merely liquidating a company in financial difficulties on the basis of a bankruptcy procedure. The goal of rescuing a company is to preserve the healthy parts of a company in trouble and to put the company back on a sound track.

This book gives practical legal – non-binding – advice on rescues. Young practitioners are writing for practitioners. The resource material is in addition useful for further academic research into the subject, especially for comparative legal analyses. The book generally reflects legal developments up until January 1996.

With respect to the use of certain words such as "company", "enterprise" and "corporation" we would like to emphasize that the different use from one report to another does not necessarily mean that they have different meanings. Likewise we did not enforce consistency in the use of the terms "reorganization plan" or "reorganization programme". They are mostly used as synonyms.

The editors thank all the national reporters very much for their outstanding contributions.
