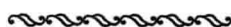

In addition to case law, the online availability of statutes, statutory indexes, legislation, court rules and orders, administrative materials, looseleaf publications, texts and periodicals makes WESTLAW an important asset to any library. Check the WESTLAW Directory or the *WESTLAW Database List* for a list of available databases and services. Following is a brief description of some of the capabilities that WESTLAW offers.

You can now search many of the WESTLAW databases using the revolutionary new WIN<sup>®</sup>, a natural language search method. Instead of formulating a query using terms and connectors, you simply enter a description of your research issue:

What is the government's obligation to warn military  
personnel of the danger of past exposure to radiation?

WESTLAW then retrieves the set of documents that have the highest statistical likelihood of matching your description.

## **Using the Index Databases to Get a Citation**

Statutory index databases (XX-ST-IDX), available for several states, contain statutory indexes as found in print publications. Use them to find the citation of a statute when you know some substantive information about the statute, such as the subject matter or procedure you wish to research. To see which states have statutory index databases, see the WESTLAW Directory or use SCOPE.

Statutory index databases contain two types of index documents:

1. Documents that contain main index headings and all references under those headings
2. An alphabetical list of all main index headings

## WESTLAW GUIDE

### Retrieving Main Index Headings

If you do not know the name of the major topic you are researching, retrieve the document that contains the main index headings. For example type

**ci(headings)**

This search retrieves the list of subject headings for that index database.

### Retrieving Specific Index Headings

To find the citations of sections dealing with a particular topic, for example, Speech-Language Pathologists, from the Enter Query screen type the following query:

**ci("speech-language pathologists")**

### Using LOCATE in an Index Document

After retrieving a document containing index references and citations, use browsing commands such as paging and LOCATE to scan your result for a specific statute reference. For example, while viewing the Speech-Language Pathologists index document, you would type the following LOCATE request to retrieve references to licenses:

**Loc Licenses**

### Using JUMP in an Index Document

Full text for a particular statute section is also available by using JUMP. To display the full text of a section, press TAB until the cursor reaches the JUMP marker (> or ►), and then press ENTER, or click from the jump marker with you mouse:

**> CA BUS & PROF § 2532**
