## PREFACE

I have followed the general approach of the previous editions of this book in attempting to present as a chronological sequence and logical unity the various elements which are commonly thought of as constituting the law of succession. The law of wills and of intestacy has generally been considered as part of the Law of Property. Probate law has usually been regarded as an independent topic of little academic import. And Administration of Estates is frequently presented as part of Equity. Yet these elements combine to form a unity, which is a striking amalgam of the various sources of English law. The law and practice of the church courts, common law and equity, as well as statute law and the more recent discipline of taxation are here joined together, but with their separate origins and influences still apparent.

I have attempted to deal with the whole of this field in a length which admits of discussion without being too bulky. In doing so, I have tried not only to explain the law, but to show how sometimes the likely result can be avoided when the interests of the client so require, for a good lawyer is not one who can merely understand and interpret the law, but one who is able to use the law in the best interests of his client. For this reason I have tried to present the law not just as a series of rather dead propositions, but to illustrate its significance in overall wealth planning.

This branch of the law has seen a number of developments since the previous edition was prepared. The most important of these has been the enactment of the Inheritance (Provision for Family and Dependents) Act 1975. Other new legislation has included the Children Act 1975, and the provisions relating to the succession to tenancies of agricultural land, and to agricultural cottages. As well as recent decisions of the English courts, I have mentioned a number of recent interesting decisions of courts in the Commonwealth.

The writer of any textbook has difficulty in the selection of material to be included, and I have been faced with two problems in particular. In the first place there is a substantial overlap between the position of personal representatives and that of trustees. I have assumed that the reader of this book will not be unfamiliar

with the law of trusts, and I have therefore felt justified in merely referring on some occasions to the equivalent position of trustees, rather than giving an exhaustive exposition. For the same reason I have had to omit discussion of such topics as the perpetuities and accumulations rules, and the equitable rules as to apportionment.

In the second place, I would very much have liked to have included a section on Capital Transfer Tax, but an account in comparable detail to the rest of the book would have required at least 200 pages, and this would have caused too great an increase in the length of the book.

The manner in which I have dealt with the material is bound to reflect my own experience as a university teacher and a partner in a London firm of solicitors. The result will, I hope, be interesting and useful to students reading for degrees, and subsequently while undergoing professional training. I also hope that they will find it worth keeping by them after qualification. By the same token, I should like to think that the book will also be of assistance to practitioners, both in the law itself, and in other fields, such as accountancy, where legal problems are never far away. But above all I hope that whoever is the reader will find this subject alive and interesting.

The law is generally stated at 1 January 1977, but I have been able to include references to certain decisions reported after that date, as well as to The Family Provision (Intestate Succession) Order 1977, which increases the amount of the "statutory legacies" payable to a widow or widower of a person dying intestate after 14 March 1977.
