Preface

Since the publications of the first edition of this book, significant changes have taken place in the rules of law affecting migration. The principles governing the right to leave any country including one's own have been profoundly influenced by the process initiated in the Final Act of the Helsinki Conference and by the work recently undertaken for the United Nations Economic and Social Council. A new Protocol on Multiple Nationality has been concluded. The International Labour Organization has promoted several new instruments, including the Migrant Workers (Supplementary Provisions) Convention and Recommendation of 1975, the Maintenance of Social Security Rights Convention of 1982 and the European Agreement on the Provision of Medical Care of 1980. At the same time it has ceased to urge its members to ratify one or two older agreements and it has taken a leading role in the movement to reduce the volume and alter the character of labour migration in Southern Africa. The Draft Convention on Territorial Asylum came to nothing; but the debates on the proposal yielded valuable material and the case-law on the Geneva Convention and New York Protocol has expanded rapidly, especially at the European level. A Protocol on Refugee Seamen has been adopted; and within the Council of Europe several Recommendations have been made, together with the Declaration on Territorial Asylum and the Agreement of 1980 on Transfer of Responsibility for Refugees.

The European Communities have doubled in size. The principles of Community law affecting migration have been given new immediacy as a result of the judgment of the European Court in *Van Duyn*, among other cases. Five new Directives have been issued and two new Regulations made, apart from the three Treaties and Acts of Accession. Within the Council of Europe, a new Convention on Social Security and one on Migrant Workers have entered into force, although the parties remain limited in number. In Africa, two new economic communities have been formed; and the Banjul Charter has been concluded, with provisions addressing the rights involved in migration. The Andean Pact has expanded its principles governing the movement of labour

and the principles applicable in the Caribbean have been modernized, with the formation of the new Community.

The changes wrought by bilateral arrangements and national law during the last fifteen years have been so large as to defy synthesis: but two trends can be detected. The first is a pervasive 'restrictionism' in immigration control, which has entailed the modification or termination of numerous labour agreements and establishment conventions and the revision of the immigration laws of most of the jurisdictions here considered. The second is the increasing penetration of international law in this area, illustrated by the effect on British nationality law of the Joint Declaration on Hong Kong or the convergence of Colombian, Ecuadorian and Peruvian aliens laws in accordance with the Code of Practice drafted in pursuance of the Pact of Cartagena.

These changes are reflected in the structure of the new edition of this book. Less space is devoted to dispelling the notion that the control of nationality and migration falls within the reserved domain. The qualifications that need to be made to that assertion are now so clear that they speak for themselves. A chapter has been added on the Right to Leave any Country including One's Own; and there are fresh chapters on Freedom of Movement in the European Communities, on Council of Europe Conventions, and on Other Regional Arrangements (Benelux, the two West African Communities, the Central African Community, the Caribbean Community, the Andean Pact and the Nordic Community). There is also a new chapter on the Expulsion of Aliens. To make space for these, the chapters dealing with the territorial application of immigration laws, with prohibited immigrants and with naturalization have been omitted; but an attempt has been made to incorporate elsewhere some of the material contained in them. Of the chapters carried over from the first edition, all have been completely re-written apart from Chapters II (Historical Perspectives) and V (Exceptional Duties to Admit Aliens); and those two have been revised. In place of a single bibliography at the end of the book, there are now separate bibliographies at the end of each chapter; for the literature on the subject has become abundant. A new table of treaties and other instruments has been compiled and the more important instruments are printed in whole or in part in a companion volume, *Basic Documents on International Migration Law*. The latter are to be made available in a separate publication, for the convenience of students and practitioners.

Grateful acknowledgement is made of a grant from the Nuffield Foundation which made it possible to engage as research assistant for six months Mr Simon Ripley, LL.B., whose diligence, skill and irrepressible good humour are much appreciated by the author. Warm thanks are also given to Mrs Kathleen Fedouloff, who produced several drafts of the text and tables on her word processor, with her customary efficiency and care and with extraordinary forbearance.

The law is stated as at 31 December 1986, although it had been possible to take account of a few major developments during the course of production.
