PREFACE

The various branches of intellectual property law—patents, trade marks, registered designs, copyright, confidence and so on—confer legal exclusivity in the market-place. The right to prevent others from using ideas or information to their own commercial advantage is not easily delineated. Legal techniques of some sophistication are called for and this has until recently made intellectual property a somewhat esoteric specialism. But, particularly in industrial, free-market economies, these intangible property rights are becoming increasingly valuable in the fight to secure and retain shares of a market. A widening circle of people need some knowledge of what they involve.

This book deals with the British law of intellectual property, in the new setting provided by EEC membership and a growing encrustation of international conventions. I have not written it for the person who understands the main characteristics of the law: specialist lawyers and professional advisers, such as patent and trade mark agents, are well supplied with detailed practitioners' texts. I am seeking rather to help the relative novice who wants something more substantial than a purely introductory account of the subject.

I have, indeed, had three types of reader in mind. First, students in universities and polytechnics, whether they are studying law in general or specialising in business law or training for one of the intellectual property professions. In Britain and the Commonwealth, an increasing number of students are tackling the subject each year. For them, I have described not only the current state of British law but have sketched in the political and economic debates which always surround the subject.

Secondly, there are lawyers, business executives and civil servants who come in contact with the field in the course of their careers and need to look at its structure systematically. Thirdly, there are specialists in the subject abroad who are looking for a relatively succinct presentation of United Kingdom law. International negotiations about intellectual property proliferate; but legal protection is still at base a matter for the domestic laws of national states. As trans-national business grows so does the

expert's need to have some acquaintance with the intellectual property laws of all major industrial countries. Within the EEC, with its special market objectives and its great interest in securing Community-wide or harmonised regimes of intellectual property, there is a real need to understand the British legal position. Both the independent development of the common law and Britain's long industrial history have given the country a distinctive experience which deserves to be better understood among our continental collaborators.

Of course, there are people in other EEC states who are well aware of this, as I have had real reason to appreciate. In 1979, I received a generous grant from the Thyssen Foundation which enabled me to spend eight fruitful months at the Max Planck Institute for Foreign and Comparative Patent, Copyright and Competition Law in Munich. I was able to write a good part of this book during that time and I benefited very much from the academic and professional contacts that I made there. In particular I participated in an instructive set of seminars on comparative intellectual property law, run by the Institute's directors, Professor Dr. Friedrich-Karl Beier and Professor Dr. Gerhard Schricker. In these the other principal contributor from the common-law side was Professor Donald S. Chisum of Washington University, Seattle.

My interest in the subject began much earlier, when the Law Department at the London School of Economics asked me to put on a course for graduate students. That course, part of the London LL.M. degree, has now run for 12 years. During that time I have learned much not only from Richard Lloyd, C.P.A., Robin Jacob and Mary Victoria of the patent bar, who have helped in the teaching, but also from our students, particularly those who have come with some experience of intellectual property, domestic or foreign. A number of people deserve very real thanks for criticism and help with parts of the manuscript: in particular, David Devons, C.P.A., Professor Gerald Dworkin, Dr. Valentine Korah, Richard Lloyd and Janice Luck.

My largest debt overall is undoubtedly to Thomas Blanco White, Q.C. He has done far more than anyone else over the last 30 years to provide British intellectual property law with a worthwhile literature. His highly informative introduction to the subject is well-known; so is the perceptive criticism that informs

the various texts that he has written or edited. When I wanted to study the subject he took me as his pupil and I had a remarkably eye-opening year under his tutelage. I very much value my continuing association with the chambers that he now heads.

In getting the book to its final form my thanks go to my secretary, Angela White, and to my wife for their unending help; to the staff of Sweet & Maxwell, who made one author's relations with his publisher so unproblematic; and to Alison Real and Heather Rogers, who helped with the indices.
