PREFACE TO THE EIGHTH EDITION

This book aims to help students acquire the tools they will need to understand the media law world of the future. In a period of dramatic changes in journalism, the media industries, and the wider legal and political environments, this task is daunting. We have tried to select materials that are most likely to be relevant in resolving future media law issues. In some instances that has meant including subjects not previously considered central to media law, such as anonymous speech and foreign law. In other instances, we seek to provide students with tools to resolve future issues by distilling from familiar precedents the fundamental principles that will continue to be the major weapons against censorship, chilling effects, and suppression of information.

This edition retains the basic organizational framework of the previous edition. Part I deals primarily with First Amendment limits on governmental regulation of media. Unlike the previous edition, Part I separately addresses materials that single out electronic media for disparate treatment and questions whether such treatment will continue in the new media environment. Part II addresses private litigation that arises from media publication. Part III deals with legislation, regulations, and judicial actions that inhibit (or sometimes aid) newsgathering.

We have tried to resist the temptation to cram ever more detail into the textual material between principal cases. What remains is material we consider essential to understanding the subject.
