### PREFACE TO THE FIFTH EDITION

The fifth edition captures recent developments in products liability and continues our ongoing quest to enhance the portrait of products liability law, theory, and practice revealed by the cases and materials assembled in prior editions. Although the rate of doctrinal change has slowed substantially from the period of tumultuous growth during the 1960s, 1970s, and early 1980s, courts, legislatures, and commentators continue to search for improved approaches to a large variety of products liability problems. Moreover, products liability "reform" in legislatures and the courts, sometimes as captured by the American Law Institute's Restatement (Third) of Torts: Products Liability, continues to affect certain aspects (usually peripheral) of this field of law.

This edition includes a number of new cases and legislative developments, but we have kept the additions modest and have continued to streamline the book, which now is the shortest it has ever been. The new edition continues to stress developments in the evolving meaning of "defectiveness" and problems of proof arising in particular from the Supreme Court's *Daubert v. Merrell Dow* decision. As in previous editions, we have updated and otherwise enriched the chapter exploring class actions and other mass tort developments in toxic substance products liability litigation.

Most footnotes are omitted from the principal materials; original numbering is retained for footnotes that remain. Asterisks designate footnotes of the editors. Ellipses, brackets, and asterisks indicate omissions. Within cases, formatting and citation form generally are standardized; page references to trial transcripts, exhibits, and pleadings ordinarily are omitted without notation; parties generally are identified by their trial designations; some citations are omitted without notation from quotations in the Notes; and certain other minor technical revisions are designed to enhance clarity of presentation.

In the process of revisions, we may have dropped or altered certain materials which various users wish we had retained. To them, we extend our permission to reproduce selected materials from earlier editions for classroom use. Many improvements in the book reflect comments from users of previous editions. We appreciate all such suggestions and hope that users of the fifth edition will continue to pass along their ideas on how the book may be improved.
