Georgia Butina Watson is Professor of Urban Design and Head of Department of Planning at Oxford Brookes University. She has co-authored several books and exhibitions on theory and practice of urban design and has been a keynote speaker at many conferences in the UK and abroad. Her professional expertise includes the study of urban morphology, community development and place identity and she is a co-author, with Ian Bentley, of *Identity by Design* (Architectural Press 2006). Ian Bentley is Emeritus Professor of Urban Design at the Joint Centre for Urban Design, Oxford Brookes University. He was lead author of *Responsive Environments* (Architectural Press 1985), author of *Urban Transformations* (Routledge 1999) and co-author, with Georgia Butina Watson, of *Identity by Design* (Architectural Press 2006). He has acted as external examiner across a range of postgraduate courses

in urban design, urban regeneration, cultural studies and public art, and has been a keynote speaker at numerous urban design conferences in the UK and internationally. He is a founder member of the urban design consultancy Place-ID, and currently leads the JCUD's outreach programme, delivering the Centre's urban design courses in the workplace to a range of local authority clients.

Mohammed Abdullah Edrees is an Assistant Professor of Urban Design at Umm Al-Qura University Makkah Al-Mukarramah city, Saudi Arabia.
