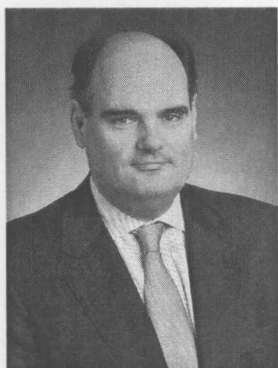

He is Professor of Public Law of the National and Kapodistrian University of Athens, where he teaches since 1990 Constitutional Law, Administrative Law and Tax Law. Since 2002 he is teaching also on a regular basis as Visiting Professor in the Universities of Panthéon – Sorbonne Paris 1 and Paul Cézanne – Aix-Marseille III. Since September 2007 Professor Fortsakis is the Deputy President of the Faculty of Law of Athens.

He practices law as a barrister mainly before the Greek Administrative Supreme Court. He is partner of the law firm 'FDM&A' (see <www.fdmalaw.com>).

Professor Fortsakis has served as advisor to the Prime Minister on issues of public law (1990-1991); expert of the Council of Europe (Strasbourg) on issues of Administrative Law and organization of the administrative justice (1998-2003); member of the Hellenic Competition Commission (2000-2003); member of the National Commission for Human Rights (2003-2006). He is member of the Board of the National Library (since 2008); member of numerous committees of different ministries for the preparation of legislative and regulatory bills and decrees.
