PREFACE TO THE TENTH EDITION

This Tenth Edition of *The First Amendment and the Fourth Estate: The Law of Mass Media* reflects the authors' belief that communication students are quite capable of reading Supreme Court opinions and that doing so is essential to understanding the thought processes of the justices who are making First Amendment law.

Throughout the book, the reader will find more than 30 principal cases, the decisions which help define communications law as we know it today. In between there are references to hundreds more cases and statutes about which we think any professional should be informed.

Since the 2004 edition, communication law has continued its rapid change and development. What we once called "new technologies" are no longer new. Questions about the Internet continue to generate new law. Debate continues about the advisability of a federal shield law, but 33 states now have shield laws. The Federal Communications Commission has relaxed cross-ownership rules. Among the cases and reports new to this edition of the textbook are *Fox Television Stations, Inc. v. Federal Communications Commission* (2007) on indecency and profanity in broadcasting, the FCC's report on *Violent Television Programming and Its Impact on Children* (2007), and *Metro-Goldwyn-Mayer Studios, Inc. v. Grokster, Ltd.* (2005).

We have used earlier editions of the book in teaching both undergraduate and graduate students and have tried to incorporate what we have learned from that experience. We welcome, of course, comments about ways of using the book or improving it.

Communication law poses difficult dilemmas as the courts try to balance rights of the media against rights of those affected by the media. We hope to have captured some of the interest and excitement inherent in the courts' attempts to deal with these challenging problems.

Thanks are due to Kevin Rollins, Eva Zelnick and Alexandra Zuiderweg for their help with this edition.

Marc Franklin, our senior author, took a much-deserved "pass" on this newest update of the book, but we are, of course, hugely indebted to him for his countless important contributions to the book, many of which remain from previous editions.
