The Planning Compendium of Opening and Development along Hebei Bohai Bay Front Line Area

The opening and development planning along Hebei Bohai Bay area covers all the territory of the Province. In order to stress the main point and to accelerate the start work, the plan will be carried on in two steps; that is, firstly plan the First Line Area defined by the Provincial Party Committee and Provincial government, and then plan the Second Line Area. This planning compendium principally makes a comprehensive analysis to the present situation of the Front Line Area and put forward strategy target, developing main point as well as the relevant policies and measures.

The First Line Area (hereinafter called planning Zone in short) includes four cities and their governed counties (cities), and also Lutai, Hangu, Zhongjie and Nandagang Farm. They are Shijiazhuang City, Qinhuangdao City, Tangshan city, Cangzhou City. The total area is 38,506 square kilometres, which accounts for 20.5% of the total area of the Province. By the end of 1991 the total population is 18.127 million which ac-

counts for 29.1% of the Provincial total. The scope of the plan will be favourable for the policies connection. It does not only covers the coastal economic opening area and coastal opening cities originally approved by the State, but also embodies the spirits of the Fifth Plenary meeting of Fourth Party Provincial Committee, so that the opening area can be enlarged progressively.

The Superiorities of the Zone and Its Restrictive Factors

I. The Superiorities of the Zone

1. The advantageous geographical position. The Planning Zone is mainly located in the eastern part of Hebei Province, facing Bohai sea and with Beijing and Tianjin back behind. It is in the forward position and centre of the whole Bohai Bay Economic Zone which is of highly opening to the outside. It can easily get the influence from Beijing and Tianjin and it has the superiorities of two-way opening. As for the connection aspect of social economic development, Shijiazhuang City is the centre of the Hebei Central and Southern Economic Zone and it will be of rigorous bring-along function to the development of the economic Zone. Tangshan and Qinhuangdao are the main body in the Eastern Hebei economic Zone and also the important component part of

Beijing, Tianjin and Tangshan economic zone. This area has been the forward position for the whole province to open to the outside and develop outward - type economy. Cangzhou has great potentiality for development. The second highway for the western coal to be transported to the eastern and the construction of Huanghua Port has brought along the broad way for the development of local and the whole province. It will become a new door opening to the outside in our Province. For the consideration of strategy distribution in Hebei Province, the first development of this area will be favourably to push forward to form progressively the Qinhuangdao, Tangshan, Langfang and Baoding opening area along the Beijing and Qinhuangdao railway to the west taking Qinhuangdao Port and Tangshan Port as lead, and with the influence of Beijing and Tianjin, the opening of Zhangjiakou and Chengde area can be pushed forward; In the southern part, Huanghua Port will be taken as lead, westward along the Shijiazhuang and Dezhou Railway, progressively Shijiazhuang, Hengshui and Cangzhou Opening Area can be formed. With the influence of Shijiazhuang, the capital of Province, the opening of Handan and Xingtai can be put forward. Pushing forward from east to west, step by step, the distribution of "Port break through, success work in the two lines, bring along two sides and opening in the whole province" can be formed.

2. Good natural resources condition. The Planning Zone has fairly abundant mineral resources and land resources which provides favourable conditions for opening and development. Flatlands make the main landforms and the climate condition is ideal, which is suitable for the growth of many kinds of plants. It is an important agricultural by-product base in the country. It has broad epicontinental sea and beaches which is the important base in the country for the production of aquatic products and salt. It has abundant mineral resources. More than 40 kinds of mineral resources have been verified in which coal, iron, quartz, limestone are of big amount. Sea salt, petroleum and natural gas are abundant in the Zone resources superiorities to develop the industries of iron and steel, energy resources, construction material, ocean and petroleum chemicals.

3. Convenient communications. In the Planning Zone there are now main railways of Jing - Shan, Jing - Qin, Da - Qin, Jing - Hu, Jing - Guang, Shi - Tai, Shi - De which undertakes the transportation of passengers and Shanxi coal to the outside in Northeast China, East China and North China. The highways radiate in all directions which connected all the main ways of Northeast China, East China and central flatland area. The sea transportation is also convenient. It is an important passage way to the sea for North China. The loading and unloading capacity of

Qinhuangdao port is 93.35 million tons, next to the Shanghai Port, taking the second in the country. Cangzhou Huanghua Port has been listed the second special passageway to the sea for coal transportation by the country and the constructions of four 35 thousand tonnage berth wharfs will be soon initiated. Tangshan Port 15 thousand tonnage berth wharf has already been putting into work, and a new berth is under construction. Shijiazhuang is in the joint place of Jing - Guang railway, Shi - Tai railway and Shi De railway, which is the important passenger and freight transportation hub in north of China. Jing - Shi highway will soon be open to traffic and a large civil airport has been begun constructing. Those will give full play to Shijiazhuang for strengthening the connection of home and abroad.

4. The high strength of economic technology. The level of development of the Planning Zone takes the first place in the whole province. Its gross national product makes up 36.9% of the whole province and its industry and agriculture output value accounts for 39.3% of the whole province. In the Zone, there are such important industrial production bases as textiles, chemical, medicine, machinery and electronics, metallurgy, building material, coal and ceramic. It has 295 large and medium - size enterprises which accounts for 42.7% of the total in the province. The Zone is converged with a large

part of provincial subordinated science research institutes and various specialists from every level. 21 universities and colleges are in the Zone, which makes up 42% of the provincial total.

5. The Zone has a good foundation for opening to the outside world. The opening areas of Qinhuangdao, Tangshan, Cangzhou and City of Shijiazhuang make use of soft environment perfectly as the time goes. The various policies of encouraging developing outward economy and promoting the opening to the outside world has become a system. And also the hard environment has been improved greatly. Through calling for business and propaganda a certain effect has been made in the abroad, which takes up an important position in the opening of the whole province. In 1991, the purchase value of exporting products takes up 47.7% of the whole province. By now, 264 foreign - funded joint - venture, joint - cooperation and sole foreign - funded busin enterprises have been built and put into production, which takes up 52% of the whole province. Actually US \$ 121.35 million foreign fund had been utilized in the last year. It accounts for 70% of the whole in the province.

I. The Restrictive Factors

Every city or county in the Zone is different in the essential conditions, especially Cangzhou and Qinhuangdao are weak in industry basis. The basic construction of facilities of most of counties are still backward; And the industry

structure and product structure are not suited to the need of outward economic development. The third industry takes a small proportion in the national economy and the primary products with low technics contained takes a bigger proportion; The reserved fund which can be used in construction by the governments of all levels are quite limited and the needed funds for accelerating development are insufficient; So far the air transportation is still inconvenient.

By comprehensive analysis, we think that the superiorities are in the leading position in the zone. Especially since entering the Eighties, the speed of economic development has been further accelerated together with the continuous deep reform and opening. The position of economic superiorities of the Zone has been consolidated and developed. Meanwhile, the layout of opening to the outside world has generally been formed. This Zone has become a key area for opening and development along the Bohai Bay Economic Zone. It will be in a decisive position in the economic development of the whole province. Speeding up the opening and developing of this district will be significant for developing vigorously Hebei economy and building up a strong economic province.

The Guiding Ideology and Strategy Target

I . Guiding Ideology

Taking the spirits of Fourteenth Session of the Party and the decision of the Fifth Plenary Meeting of the Provincial Party Committee as guide and according to the concret conditions of the Planning Zone and demand of promoting the opening and development in the whole province, our guiding ideology of opening and developing the economy in first line along the coastal area is: Concentrating our energy and break through the key work; Start immediatly and unconventionally develop; Two - way opening and bring along the whole province.

—— Strengthen reform and opening to the outside. According to the requirement of socialist market economic new system, concentrate our energy and choose correctly the point to break and enable the Zone go firstly in building up the system of market economy so that it can go in front line of the province in opening. Speed up changing of economy from innerward economy as lead to outward one as lead, strengthen progress of science and techonolgy and progressively realize advance and high efficiency of the industry structure.

—— Make full use of the favourable condition of opening to the outside, with no hesitation use flexibly the favourable policies stipulated by the country and province, hold on the opportunity that the key points of foreign investment will be transferred to the north and China will be re-

sumed as a signatory state in GATT, go into action promptly and take unconventional measures. Expand opening, accelerate developing and realize leap development of economy.

— Persist in "two - way opening" to home and abroad and enable inter - cooperation, promote introducing foreign investment. Bring the superiority of around Beijing and Tianjin into full play and introduce still more and better talented persons, technology, information and funds which are important factors for the above - mentioned to develop and strengthen ourselves and increase foreign interests for investment. At the same time maintain close ties of the planning Zone with regions from other provinces and develop regional contacts and cooperations in the inner - province so that step of the whole provinces opening can be accelerated.

I . Strategic Target

Based on raising economic efficiency and improving structure, achieve the high speed increasing of national economy; By the end of this century the gross national product will be increased by over three times. We will make the planning Zone be the first to connect with international economy. Then it will be the zone of the most opened, the most developed market, the most strong actual strength, the fastest development, the richest living of people and the best construction of spirit civilization of people. By the year of 2010, Qinhuangdao, Tangshan,

Cangzhou, Shijiazhuang and also the counties or cities of better conditioned will basically realize the modernization.

— In the ninties, the increasing speed of GNP of the Zone will reach 12—14% which is higher than the average level of the province by 2—3%. By year of 2000, the gross national product value of the Zone will reach 108.8 billion yuan which is nearly three and half times higher than that of 1980. From 1990 to 2000, the increase value of the first industry will reach 11 billion yuan and yearly increasing value is 4%; The increase value of the second industry will reach 52.8 billion yuan and yearly increase value is 14%, The increase value of the third industry is 45 billion yuan annul average increase by 18%. The proportion of the first, second and third industries will be 10.1 : 48.5 : 41.4. By the year of 2010, the gross national production value of the whole Zone will reach 389.6 billion yuan.

— By year of 2000, the gross national product value per capita will reach 5475 yuan, which is higher than the average of the whole province by 2055 yuan; By the year of 2010, 17,691 yuan will be obtained, which is as two times as the average of the province. When the time comes, the gross national product value per capita of Qinhuangdao, Tangshan, Cangzhou and Shijizhuang will reach the level of medium developed countries.

—— The fast increasing of fixed assets investment, the consolidated economic foundation, the strengthened potential power of development. In the duration of 1990 and 2000, the fixed assets investment rate of the whole society will be kept at 33% and the accumulate total fixed assets investment of the whole society will reach 190.3 billion yuan.

—— Develop widely the channels and attract foreign investments by using of various methods. By the year of 2000, the annual actually using of foreign funds will be accumulated to US \$3 billion and the number of enterprises of foreign-funded joint ventures, joint cooperation and sole foreign business will reach from 4000 to 5000.

—— Adhere to carrying on foreign economy and foreign trade simultaneously and further having a deeply reformation in the foreign trade system. Expand actively the import and export trade and go all out to open up international market to get the result of 18.2% increasing annually foreign currency by exporting. By the year of 2000, the total export of the Planning Zone will account for 30% of the total gross national product. The dependence rate of foreign trade to GNP will be around 40%.

—— Through reform and opening to the outside and industry structure improving, a rational city and town system can be formed; We will make Qinhuangdao, Tangshan, Cangzhou
