#### 前 言

信息技术正在被大量地用于政府对城市建设和经济运行的管理和调控。1993年在北京经济形势分析与预测课题组刚刚成立,第一本经济蓝皮书于1994年上半年问世的时候,经济信息的处理还处于相当稚气、甚至是手工操作的阶段。目前使用电脑处理信息已经普遍化了。但是大量的信息,多半是经过处理的信息,仍然使政府决策层很难及时判断出现的情况,并做出无误的决策。

为了解决这个问题,我们在北京经济形势分析课题组的基础上1996年成立了北京经济决策支持系统研究课题组。该课题在1999年12月结题。课题组在三年时间里,完成了以下六个软件系统:

- (一) 北京劳动就业决策支持系统
- (二) 北京物价决策支持系统
- (三) 北京郊区农业决策支持系统
- (四) 北京700年自然灾害查询系统
- (五) 地区宏观全融风险预警系统
- (六) 北京经济综合决策支持系统

目前除《地区宏观金融风险预警系统》由于数据不全,作为一个模拟系统与进入使用阶段有一段距离外,《北京物价决策支持系统》和《北京劳动就业决策支持系统》已交北京市物价局和北京劳动局试用。其他几个系统也将在近期交由实际部门使用,并在使用中进一步完善。

在以上系统研制过程中我们付出了艰苦的努力。但是从政府决策层的需要和信息化的迅猛进程来看,对于以上系统下一阶段的研究,还有大量的工作要做。我们准备向两方面努力。

- 1. 在以上各系统的基础之上,为市委、市政府的领导构建一个对城市建设和经济运行进行全方位宏观调控的平台。这个平台不仅包括信息查询模块,还包括管理视图;判断、思维模块;动态流程模块;政策模拟模块和调控、反馈模块等等。
- 2.为"数字北京"的人文信息建设作出贡献。"数字北京"将包括种类多样的信息:如地形、地貌、山脉河流、气候气象等,又有历史沿革、风土人情、城市建设、文教、经济、人口、军事、可持续发展等等,缺了哪一方面也不完整。"数字北京"的建设是一个挑战性的目标,虽然目前现有的技术基础还不足以支撑这个综合性目标的实现,但是我国在地球科学的信息化方面,特别是地理信息系统、卫星遥感、航空遥感都已经有了相当雄厚的基础。社会科学为此也需要迅速积累和迎头赶上。我们理当在已有工作基础之上,为人文、特别是经济、城市方面的信息化建设作出应有的努力。
