

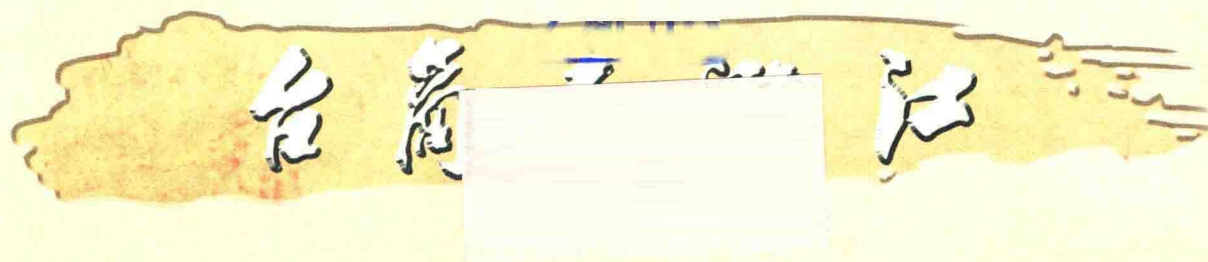

寫在前面

這是一塊沃土，在這塊土地上，浸潤着七千年的歷史，積澱着七千年的文化。

這是一片熱土，在這片土地上，創造着經濟發展的奇迹，高奏着改革開放的凱歌。

這就是浙江，一個在中國版圖上僅占十萬平方公里的小省，一個曾經以農為主、資源短缺的窮省，祇用了20多年的時間，就以驕人的建設成就實現了持續的跨越式發展，成為祖國大陸騰飛的縮影和“窗口”。今天，它以中國約百分之一的國土面積、百分之三點五的人口，創造了祖國大陸百分之七點五的國內生產總值。浙江在“長三角”南翼的崛起引來世人的矚目和贊譽。

當我們的思想越過七千年的時空，去追溯河姆渡時代，我們禁不住要為先人們的偉大而驕傲，河姆渡文化不僅證明了先人們曾經創造的輝煌，而且也證明了長江流域同黃河流域一樣都是中華文明的發祥地。可以告慰祖先的是，今天，河姆渡人的子孫後代，同樣也在創造輝煌。他們絲毫沒有遜色于先人，我們同樣可以引以為自豪。

需要特別指出的是，當我們為浙江的進步而歡欣鼓舞時，決不能忘記在浙江大地上與我們一起創業的臺灣同胞。同是華夏兒女，皆為炎黃子孫，甚至都是河姆渡人的後裔（據兩岸不少專家考證，臺灣早期的先民是河姆渡人利用最後一次“海退”從浙江遷徙過去的）。成千上萬的臺灣同胞先後到浙江投資創業，與浙江人民并肩奮鬥，共同打拼，浙江發展的成就，包含着他們付出的辛勞和汗水。

臺商到浙江的歷史，起始于八十年代後期，早在臺灣當局開放臺灣同胞到大陸探親之前，就有少數臺商被祖國大陸的改革開放所吸引，悄然登陸。進入九十年代，更多的臺商開始到大陸尋找商機，投資創業。先是投石問路，繼而陸續跟進，再而紛至沓來，最後蜂擁而至。其間，受臺當局“戒急用忍”政策所阻，屢有波折，但臺商西進大陸的脚步始終沒有停止。目前，臺商投資浙江可以說是高潮迭起，方興未艾。至2002年底，浙江已累計批准臺商投資企業4418家，總投資為128.32億美元，合同臺資104.33億美元。在祖國大陸各省區中列第四位。近兩年，由于“長三角”的“磁吸”效應，浙江引進臺資更是屢創新高，僅次于廣東、江蘇兩省，

浙江已成為祖國大陸與臺灣經貿聯系最為密切的省份之一。

同胞情深，血濃于水，為了切實保障臺灣同胞的切身利益，依法保護臺商在浙江的投資經營活動，浙江省始終不渝地貫徹江澤民主席提出的“不以政治分歧去影響、幹擾兩岸經濟合作”的主張，致力於投資環境的改善。浙江省人大常委會根據全國人大常委會頒布的《臺灣同胞投資保護法》和國務院頒布的《臺灣同胞投資保護法實施細則》，審議通過了《浙江省臺灣同胞投資保障條例》。每年，省人大和政府相關部門都要進行執法檢查和調研，以推動法律的實施。這就有力地保障了臺商的正當權益，推動了兩岸的經貿合作。以省、市、縣三級政府臺辦為主構建的服務網絡，更是為臺商在浙江的工作、學習和生活創造了有利的條件，我作為省臺辦的工作人員，既是這一段歷史的見證人，同時也以有機會能為臺灣同胞提供服務、奉獻心力而感到欣慰。

八年前，當我到臺辦開始履職的時候，浙江的臺商還為數不多。如今，臺商在浙江已蔚成大觀，數以千計甚至萬計的臺商遍布浙江大地。杭州、寧波、溫州、紹興、嘉興等臺商密集的城市，都已建立了臺灣同胞投資企業協會。這些年來，我與廣大臺商從相識到相知，建立了深厚的友情，結交了一大批朋友。從他們身上，同樣顯現出中華民族聰明智慧、吃苦耐勞、頑強打拼、樂善好施的品德，我常常為之感動並受益匪淺。

為了展示浙臺經貿交流與合作的成果，介紹浙江的投資環境，也為了反映臺商在浙江投資創業的情況，讓更多的人了解他們，我們編印了這本畫冊。因受條件和篇幅的限制，可能還不足以反映在浙臺商的全貌，但是我相信，作為一個側面，人們還是可以從中領略臺商在浙江的風采。

最後，我由衷地祝願：所有在浙江的臺商朋友們事業興旺，諸事如意，天天向上；所有兩岸的同胞們攜手合作，互利雙贏，共創中國人的二十一世紀！

Prelude

This is a rich land where a seven-thousand-year history has been cultivated and a seven-thousand-year civilization has been accumulated.

This is a hot land where economic development has performed a great miracle and the opening-up policy has proved successful.

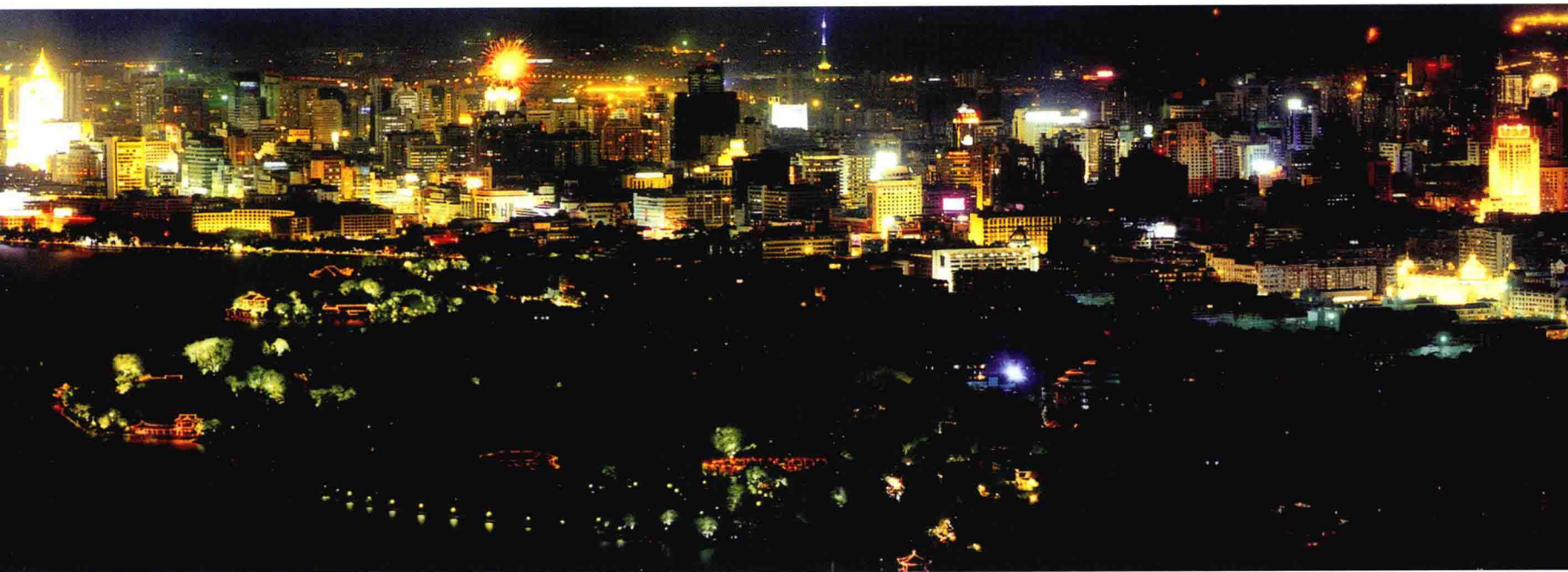
This is Zhejiang, covering a territory of 100,000 square kilometers in the southeast of China.

Twenty years ago, Zhejiang was still backward in terms of economy. Agriculture was the main industry but lack of resources. But today the GDP made by Zhejiang people whose proportion number in the whole country is only 3.5 percent has amounted to 7.5 percent of that the mainland has made. Zhejiang succeeded in marking her debut in the south wing of Yangtze Delta. The remarkable achievements have proved her to be the vivid epitome of mainland's sharp rise in comprehensive strength.

Drive our thoughts back to the Hemudu Times. The civilization made seven thousand years ago is sure to win people's admiration. What it demonstrates is not only the marvellous accomplishments that our predecessors has made but also Yangtze River's significance as another birthplace for Chinese civilization. Our ancestors can feel gratified because what their descendants have achieved today is never inferior to them.

Inspired by the rapid progress, we should keep in mind that parts of economic development should be attributed to the large number of our compatriots from Taiwan. All of them are generations of the Yellow. And it's even said that they are also the descendants of Hemudu People (experts from Taiwan and the mainland have found that some Hemudu people had moved to Taiwan Island by taking advantage of sea recession). Hadn't they devoted their hearts into the economic building, Zhejiang wouldn't witness a brilliant developing situation so soon.

Taiwan merchants have experienced four periods to undertake investment in Zhejiang. In the later 1980s, Taiwan Government still gave no official permission for the people to visit their relatives in the mainland. In spite of that, a small number of businessmen couldn't resist the attraction of motherland's preferential opening-up policy and threw the first stone to clear the investing road in Zhejiang. Ten years later, many more investors realized the business potentiality of the mainland and set foot there one by one. In the new century Taiwanese initiated an exciting stage to establish enterprises in full swing. In the following years, "no haste, be patient" policy had been a barrier but never a stop to the trade exchange. By the end of 2002, Zhejiang had been home to 4,418 Taiwanese-owned enterprises, making a total investment of USD 12.832 billion and a contractual capital of USD 10.433 billion,

ranking the fourth among all the provinces and regions throughout China. In the recent two years, as a result of the economic radiation of Yangtze Delta, Zhejiang has made many super records in absorbing Taiwan capital and become one of the provinces that have built close economic relationship between the mainland and Taiwan, just next to Guangdong and Jiangsu in order.

As the saying goes, blood is thicker than water. President Jiang Zemin's idea that politics shouldn't influence or interfere the economic cooperation between the two sides has been adhered to by the Zhejiang province persistently. In order to help undertake the investing projects by law and guarantee the immediate profits of our Taiwan compatriots, Zhejiang Provincial Investment Protecting Rules for Taiwan Compatriots has been considered and passed by Zhejiang Provincial Standing Committee of People's Congress in accordance with Investment Protecting Law for Taiwan Compatriots and Detailed Implementing Rules on Investment Protecting Law for Taiwan Compatriots issued by the Standing Committee of National People's Congress and the State Council separately. The annual inspection and investigation carried out by relevant departments can protect Taiwan investors' rights powerfully and promote the economic exchange between the two sides along the Taiwan Strait. Besides, the provincial government as well as the municipal and county ones have all set Taiwan Affairs Office to assure advantageous working, studying and living conditions for Taiwan merchants.

Eight years ago when I became a member of Taiwan Affairs Office, it was not so easy to see a Taiwanese-owned enterprise. But now, all parts of Zhejiang province can see Taiwan investors, especially Hangzhou, Ningbo, Wenzhou, Shaoxing and Jiaxing where the local Taiwanese-owned Enterprise Society has been founded. My work brought me a lot of chances to make friends with Taiwan investors. Their wisdom, diligence and generosity impress me so much that I feel quite satisfied to give service to them.

Restricted by the objective conditions, the album is never enough to give a full view about the Taiwan merchants. But in one respect it acts as a stage to show the achievements of the economic communication and cooperation between Taiwan and Zhejiang as well as the investing environment of Zhejiang Province. And also we sincerely hope that the album can be a window for more and more people to get acquainted with Taiwan investors and have an idea about their current investing situation in Zhejiang.

Finally, I want to send best wishes to all Taiwan merchants in Zhejiang: May good luck always surround you in business and in life. A 21st century specially for Chinese is ascertained as long as we never stop striving hand in hand.

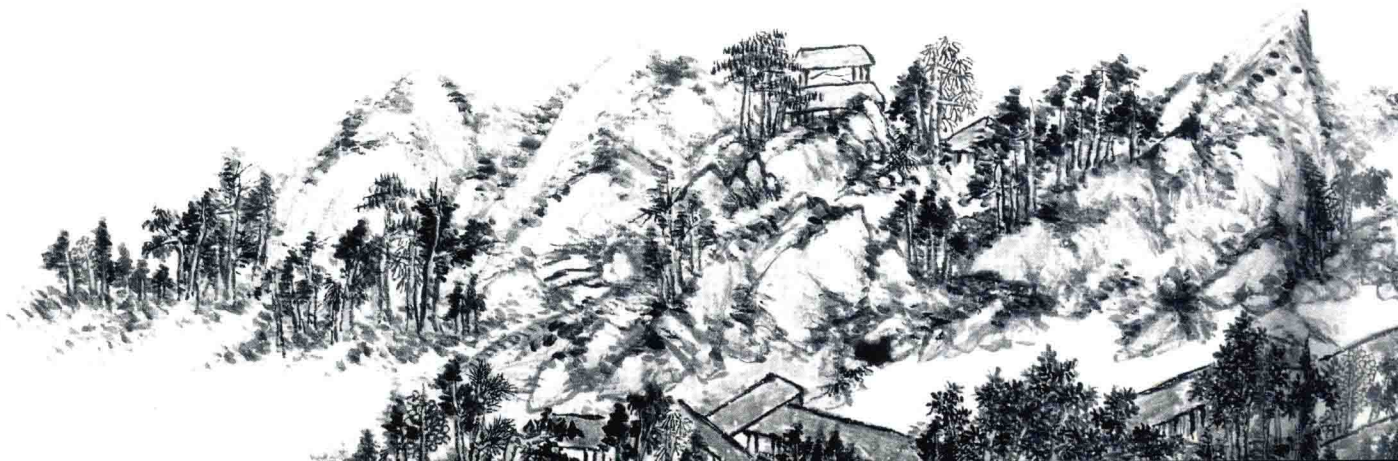

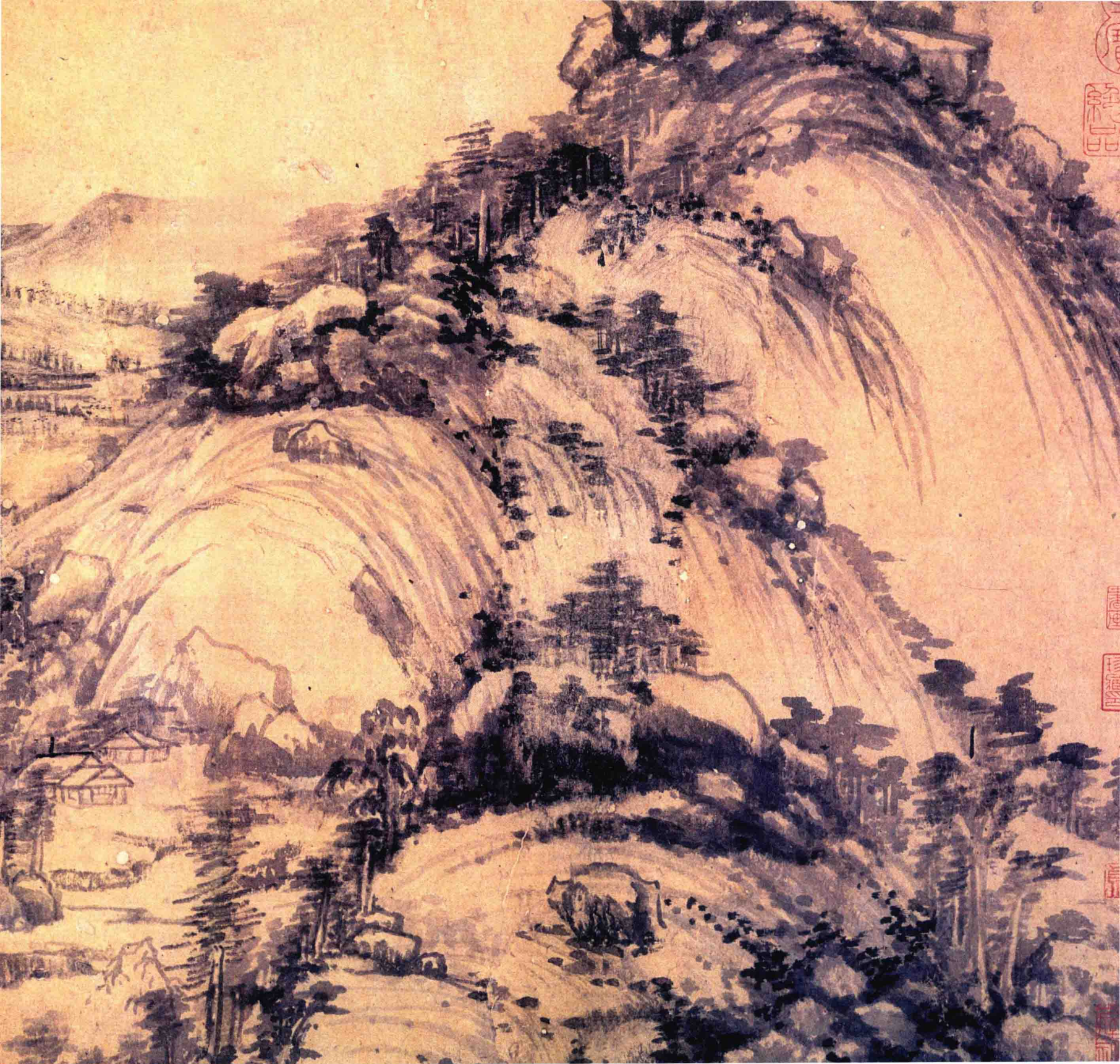
