重症医学作为一个年轻而充满活力的学科，正在蓬勃发展。重症医学科（ICU）不但已成为现代化医院救治危重病人的重要平台，而且在国家突发公共卫生事件中（如2003年SARS、2008年汶川大地震等）发挥了重大作用。

在党和政府的直接关怀下，我国各级卫生行政主管部门已充分认识到重症医学的重要性及必要性，重症医学科已在各级医院迅速普及。2009年，卫生部公布相关文件，在《医疗机构诊疗科目名录》中增加了一级诊疗科目“重症医学科”，这标志着国家对重症医学的正式承认。

尽管国内重症医学取得了巨大进步，专业人员梯队业已形成，部分医院的ICU硬件条件甚至已达到国际先进水平，但各地区之间重症医学水平参差不齐，国内总体水平与国外也存在一定差距。

重症医学的相关知识更新较快，如何保持专业知识的先进性显得尤为重要和迫切。为了更好地借鉴和学习国外的先进经验，我院朱曦教授组织危重医学科等相关科室的同事们，经过两年多的辛勤工作，翻译了第6版《欧氏重症监护手册》。该书内容丰富，讲解详细，理论与实践相结合，是一部适合重症医学及其相关专业医护人员阅读的临床参考书，希望能对重症医学及相关专业的同道们有所裨益。

重症医学 (critical care medicine, CCM) 是一门研究危重症疾病发生、发展规律及其诊治方法的学科。它随着现代医学技术的发展而产生,是现代医学不可或缺的重要组成部分。作为重

症医学的临床基地,ICU (intensive care unit) 汇聚了医院最高、精、尖的救治设备,同时收治的也是最疑难、最危重的患者。它是现代化医院最高救治水平的集中体现,发挥着不可替代的作用。

重症医学本身也面临着巨大挑战。随着研究的日益深入,越来越多的新知识、新观念在冲击着我们的头脑,在挑战着我们现有的治疗模式、策略。而越来越多的新装备、新技术、新疗法不断涌现也要求我们必须掌握更多的知识、技能。因此,一路走来,重症医学的同仁们越来越清楚地认识到,无论是对于知识构架,还是对于临床实践、科学研究,知识的更新、保持先进理念显得尤为重要。

在此背景下,北京大学第三医院朱曦教授组织了重症医学科的同道们,经过两年辛勤工作,翻译了第6版《欧氏重症监护手册》。该书是世界重症医学专业领域较权威的专著,由著名重症医学专家 Andrew D Bersten 和 Neil Soni 两位教授主编。第6版在第5版的基础上,结合近5年来重症医学领域的最新进展,系统阐述了重症医学及其相关领域的知识和最新进展。希望读者能够通过仔细研读,提高重症医学及相关专业领域的理论水平和临床实践能力,从而提高我国重症医学的整体水平。

译者前言

重症医学 (critical care medicine) 是现代医学发展的产物, 它发展迅速, 朝气蓬勃。近年来, 国际重症医学界开展了大量大规模多中心临床研究, 以循证医学的方法为基础推出并更新了一系列新的指南, 大大地改善了患者的预后。

在我国, 重症医学事业的发展有着起步晚、发展快的特点。特别是在经历了汶川大地震等一系列重大公共突发事件后, 重症医学凸显了它的独特优势和魅力, 使得作为重症医学的临床基地——重症医学科 (ICU) 在我国得以迅速普及和发展。但各地各级医院重症医学科的发展良莠不一, 水平参差不齐。

国际学术动态正在预示着重症医学发展的巨大潜力, 抓住这样的机遇是我们这一代人义不容辞的责任和义务。如何让国内重症医学从业人员对危重病的认识统一思想, 而又紧跟国际前沿, 使医疗水平在更高的层面上达成一致的难题就摆在了我们面前。

为此, 我们组织了北京大学第三医院、卫计委中日友好医院、首都医科大学附属北京朝阳医院、首都医科大学附属北京地坛医院、中国人民武装警察总医院等医院危重医学科、心脏外科、儿科的临床一线医师、药师, 通过两年时间, 翻译和校对第 6 版《欧氏重症监护手册》。

《欧氏重症监护手册》自 1979 年第 1 版发行以来, 经过三十余年的反复修改、补充, 已成为当今重症医学界最为权威的书籍之一。其作者都是来自全球各国重症医学领域、工作在临床一线、具有丰富的重症患者救治经验的专家。第 6 版是作者在第 5 版的基础上, 结合近 5 年来重症医学的最新进展, 对大量新指南、新文献进行复习之后, 对全书进行了适当的修改、完善, 进一步丰富了全书, 内容新颖、深入、翔实。全书分为 17 部分, 106 章。本书主要的读者对象是从事 ICU、急诊工作的医护人员及其专业的研究生, 可作为学习重症医学基本理论、基本技能的重要参考书。对其他专业的医务人员掌握如何对重症患者进行抢救也会有很大帮助。
