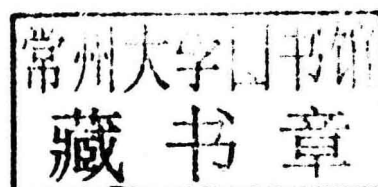

The method is to convert the monthly data for Foreign Direct Investment, Imports, Exports and Trade Balance measured by US dollar, which are published by the Ministry of Commerce and the General Administration of Customs of China, to monthly data measured in SDR. The monthly SDR value is averaged by the daily SDR value against US dollar published by IMF. Quarterly and annual data are aggregated from the converted monthly data.
