

# 前言

自加入世界贸易组织以来,我国的国际经济贸易地位不断提升,国际商务交往更加频繁。 《职通商务英语听说教程》是为高职高专商贸类专业的学生及具有相应英语水平的商务工作者 与英语爱好者编写的基础课程教材。本套教材突破了传统的教材编写模式,综合考虑了高职高 专商贸类专业学生的实际英语水平以及他们的主要就业岗位对其专业能力的基本要求,力求把 英语听说技能的培养和商贸知识的教学结合起来,通过内容丰富、难度适中的商务英语听说材料,循序渐进地使学生在仿真的商务实践活动中提高商务英语的运用能力。

《职通商务英语听说教程》通过分析高职高专商贸类专业工作岗位对应聘者英语应用能力的需求,立足于"提高语言技能,拓展商务知识",从高职高专学生的实际水平出发,从语言的基本单位入手,合理安排了商务材料在三册书中的比例,突出实践环节,重视能力培养。本系列教材在选材及练习设计上始终遵循"学练结合,重在运用"的原则,以课本为主要依托,辅以MP3录音和网络资源等现代化教学手段,为学习者营造了立体化的商务英语听说学习环境。



# 《职通商务英语听说教程》的主要特点

#### 1、重视职业岗位技能需求

《职通商务英语听说教程》以商贸类英语专业对应的职业岗位为核心,根据各岗位的工作任务及能力需求制定了科学合理的单元主题,并根据各岗位所需的英语语言技能要求设计听说训练方式。通过提供涉外商务活动中的基本对话和较高水平的听说训练,学生学完本套教材后可以基本胜任商贸类工作的各个岗位。

#### 2、突出商务题材模块化

《职通商务英语听说教程》共分三册。第一册、第二册注重通用的商务英语交流技能训练,这两册采用相同的单元教学模块设计,主题鲜明,学习目的明确。各个单元包含分工明确的模块、背景知识介绍、商务场景重现和知识点的罗列等。编者针对部分能力较强的学习者还提供了拓展思维的模块。第三册强调外贸业务专业知识的听说训练,该册根据主题划分单元,每单元根据任务划分模块,重点突出,听说结合,信息明确。

#### 3、安排教学内容阶段化

《职通商务英语听说教程》的编写充分考虑到学生的实际英语水平。各册的体例设计在保持模块一致性的同时,内容由浅到深,由易到难,由简单的商务场景逐渐向复杂的商务场景延伸。 整套教材既有系统性,又有阶段性,内容从基本的商务主题,如求职面试、打电话、商务会议、商务演示等,逐渐过渡到专业性较强的商务工作,如询价与报价、支付条件、包装、装运、商检与保险、投诉与索赔等,教学安排层次分明。

#### 4、配备教辅材料立体化

《职通商务英语听说教程》注重课堂活动的目的性及可操作性,强调听说能力的综合培养。教材中各种活动都有明确的教学目标,教师用书中还为具体的教学活动提供了详尽的操作步骤和参考信息,增强了教学活动的可操作性,为教师组织课堂教学提供了多种选择。配套光盘中的内容突出了教学设计,结合了最新的多媒体技术,引入了大量师生间的互动活动,突出任务教学、案例教学的特点,充分考虑了各种活动在课堂教学和自主学习中的可操作性。

# 《职通商务英语听说教程》的结构

《职通商务英语听说教程》共分三册,除主教材外,还配有《教师参考书》以及MP3录音光盘、电子教案、多媒体学习课件及网络学习资源。

本套教材分为两大阶段使用,第一阶段(第一册、第二册)突出通用的商务英语交流技能训练,每册包含10个单元,采用相同的教学模块设计,主题鲜明,学习目的明确。第二阶段(第三册)突出外贸业务工作流程技能训练,全书分为7章,并根据章节特色分为20个单元,每单元根据工作任务的特点分成3个模块,重点突出。

《职通商务英语听说教程教师参考书》采用与主教材配套的单元结构,每单元都提出了教学目标,并提供了参考资料、教学建议、参考答案、听力原文等内容,针对重点、难点部分还

适当加入了丰富的延伸材料,以方便教师进行课堂教学。

《职通商务英语听说教程》系列教材由长沙民政职业技术学院应用外语系主任贺雪娟教授担任总主编。《职通商务英语听说教程2》的主编为长沙民政职业技术学院的唐菁、李涵,参与编写此书的其他编者包括潘静、游娟、覃蔚、何荣辉、陈懿、杨亮辉、刘玉丹、王治。大连理工大学的孔庆炎教授担任了《职通商务英语》系列教材的总主审。外籍专家Hal·J·Mettes先生以及Caroline·J·Mettes女士也参与了《职通商务英语听说教程2》的审稿工作。

本套教材在内容设计和材料选取上均做了不少新的尝试,编者真诚地希望使用本套教材的 学生和教师能对教材的不足之处提出宝贵意见,以便我们今后加以完善。

□ 语言要点 (Language Points)


根据主题列举重点句型, 力求夯实学习者的英语语言基础。




