## 前　　言

《外贸英语惯用词语解析》是一本实用性外贸英语参考书。书中汇集的全是外贸业务中常用的惯用词语。正确使用这些惯用词语可以使文字和语言言简意赅，收到事半功倍的效果。

本书共收集近 500 条惯用词语，大致可分成两类。一类是通用型，一类是专业型。所谓通用型是说在各行各业都可能会用到，比如：meet with（得到，会见），to be interested in（对……感兴趣），subject to（以……为条件）等。而所谓专业型是说只有在外贸业务中才会用到，如：offer firm（报实盘），place order（订货），take delivery（提货）等。每一条除了指明词性及意义等外，都列出两条以上例句加以说明。例句中有的还进行分析比较，还有的列出多种可以替代的或解释性的同义例句，还有的列出易于出现的误句，以警示读者。这些例句内容反映的都是外贸业务中可能出现的情况，旨在造成一种外贸气氛，从而使读者一拿起本书就感到置身于外贸实务中。

编写本书的目的在于帮助读者学好外贸专业英语和与之相关的外贸基本知识。因此，本书不仅适用于外贸专业在校学生，也适用于外贸专业工作者。
