# 使用说明

一、本辞典以准确、简明和实用为宗旨，收集世界贸易组织（WTO）文本和各项协议的词目以及与 WTO 直接相关的词目共计 800 多条。

二、本辞典所收词目按先后顺序大体分为五个部分：WTO 的基本情况与协议文本；以东京回合为主的各次多边贸易谈判；乌拉圭回合谈判；发展中国家与 WTO；中华人民共和国加入世贸组织议定书。

三、各部分词目均按其内在联系分类排列，以便通读词目解释，即能了解 WTO 的全貌。

四、为便于查阅，除词目解释前有《词目表》外，词目解释后附有按词目的首字笔画数和起笔的笔形、一|丿顺序排列的《中文索引》和按第一个词（包括冠词）的字母顺序排列的《英文索引》。

五、书后附有 WTO 基本文本、秘书处组织系统、WTO 缔约方名单和适用 WTO 的非缔约方名单、中华人民共和国加入世贸组织议定书。
