一、《新疆生产建设兵团统计年鉴—1999》是一部全面反映新疆生产建设兵团国民经济和社会发展情况的综合性资料年刊,反映了兵团和各师(局)1998年国民经济和社会发展各方面大量的统计信息,1950年或1978年以来的主要统计数据以及国有、股份制独立核算农、工、建、交、批发零售贸易企业的主要统计数据,兵团、师(局)和企业主要经济指标排序资料及其与各省市主要指标排序资料,香港、台湾、澳门地区主要经济统计资料。

二、《年鉴》编排在上年的基础上做了部分调整,分为综合篇、师(局)篇、企业篇、其它篇、排序篇和附录篇,在每一篇中又分为若干部分,附有主要统计指标解释和统计图。

三、《年鉴》中使用的度量衡单位均采用国际统一标准计量单位。

四、《年鉴》根据出版要求,标明的1999年是出版年份,而资料则是1998年度的。

五、1998年由于单位归属变动,兵直二二一团、二二二团分别划归哈管局、外经贸局,该三个单位部分指标口径与1997年不可比。另外,根据国家统计报表制度的要求,在岗职工年底人数、职工工资总额、平均工资等有关指标中,均不包括离开本单位仍保留劳动关系的有关指标。

六、《年鉴》中符号含义的说明:

“...”表示数据不足本指标最小单位数;

“空格”表示无指标数据;

“#”表示其中的主要项;

“—”表示数据不可比。
