#### **BRIEF INTRODUCTION**

The China International Trust and Investment Corporation (CITIC) was established on October 4, 1979, immediately after China had adopted its open economic policy. The Corporation is an enterprise under the direct leadership of the State Council of the PRC.

The Board of Directors of CITIC consists of responsible persons representing various state commissions and ministries, provincial and municipal governments, well-known economists, former industrialists and businessmen and eminent personages from Hong Kong and Macao.

The main function of CITIC is to absorb and utilize foreign funds and bring in foreign advanced technology, equipment and managerial expertise, in accordance with the Law of the People's Republic of China of Joint Ventures Using Chinese and Foreign Investment and other relevant laws and regulations, making investment in construction projects. Stress is laid on the technical up-dating of existing domestic enterprises and exploration of natural resources as well as investment overseas in projects involving natural resources needed by China, with a view to helping speed up the modernization program of China's national economic construction. Its main business activities include the following:

- 1. Organizing various forms of economic cooperation involving both Chinese and foreign participants, such as joint ventures, co-production, compensation trade, etc.:
- 2. Making investment at home and abroad;
- 3. Promoting technical cooperation between China and foreign entities;
- 4. Engaging in international financing business, including the acceptance of trust funds and trust deposit for investment as well as issue of corporate debentures;
- 5. Handling imports and exports for those enterprises in which CITIC has made investment:
- 6. Operating both domestic and international leasing;
- 7. Dealing in real estate business;
- 8. Providing consultant services for domestic and overseas clients:
- 9. Providing investment security insurance for foreign investors making investment in China;
- 10. Engaging in agency business on matters relating to the above.

During the four years since its founding, CITIC has established business relationship with its counterparts in scores of countries and Hong Kong and Macao region, and has developed various forms of cooperation. It has succeeded in organizing and setting up nearly forty joint ventures involving either foreign investors or funds raised abroad; providing hundreds of Chinese enterprises with advanced and suitable foreign equipment by way of leasing through the two leasing companies participated by CITIC.

In early 1982, CITIC succeeded in issuing in Japan its first corporate debentures by private placement. For the purpose of facilitating economic and technical exchanges with foreign countries, CITIC has set up a branch office in Hong Kong and two representative offices in Paris and Tokyo. In the future, when necessary, it will establish offices in other countries.

Looking forward to the year of 1984, CITIC's business will be developing further in big strides in keeping with the steady progress of China's political and economic situation and the further implementation of its open economic policy. The Corporation earnestly welcomes friends from financial, industrial and commercial circles of other countries, overseas Chinese, compatriots of Taiwan, Hong Kong and Macao and overseas Chinese descendents to hold discussions in any of the aforementioned business fields, striving to make its own contribution to the acceleration of China's modernization program and the promotion of international economic and technical exchanges.




