一、《西藏统计年鉴》(2000)是一本信息高度密集的资料工具书。本书收录了2000年西藏的经济和社会发展等各方面的统计数据,以及建国以来各个主要时期的一些主要统计数据。是国内外各界人士了解西藏认识西藏的重要资料性工具书。

二、全书内容分为19个篇目,即1.行政区划和自然资源;2.综合;3.人口;4.从业人员和职工工资;5.固定资产投资;6.财政;7.物价指数;8.人民生活;9.农业;10.工业;11.建筑业;12.运输和邮电;13.国内贸易;14.对外经济贸易和旅游;15.金融和保险;16.教育、科技和文化;17.卫生、体育;18.各县(区、市)主要统计资料;19.全国各省(区、市)统计资料。为便于读者正确使用资料,书末还附有主要统计指标解释。

三、本年鉴中总量指标计算均为1999年现行价格。

四、本年鉴部分数据合计数或相对数由于单位取舍不同产生的计算误差未作机械调整。

五、本年鉴对以前的统计资料重新进行了核实,相应地调整了部分数据。读者在使用历史资料时,凡与本年鉴有出入的,均以本年鉴为准。

六、本年临的资料大部分来自年度统计报表,部分来自抽样调查。

七、本年鉴中的符号使用说明:“…”表示数据不足本表最小单位数;“空格”表示该项统计指标数据不详或无数据;“#”表示其中主要项。

八、资料中所使用的度量衡单位采用国际统一标准计量单位。

九、《西藏统计年鉴》公开出版以来,受到了国内外广大读者的关心和支持,对本年鉴的内容和编辑工作提出了许多宝贵意见,同时得到区直有关部门和单位的大力支持,对此我们深表感谢。限于我们的水平,欢迎读者继续对年鉴的不足之处给予批评和指正,帮助我们进一步改进年鉴的编辑工作,以便我们更好地为广大读者服务。

VIII .The international standard units of measurement are applied in this yearbook.

IX .Previous editions of Tibet Statistical Yearbook have won wide acclaim among the readers.
