

## 编者说明

一、《福建统计年鉴—2008》是一部全面反映福建省国民经济和社会发展情况的资料性年刊。全书系统收录了2007年福建省全省及各地区、各部门经济、社会和科技等方面大量的统计数据，以及建国以来全省国民经济主要指标的历年数据。

二、《福建统计年鉴—2008》内容分为18部分，即(一)综合；(二)国民经济核算；(三)人口与劳动力；(四)固定资产投资；(五)人民生活；(六)物价指数；(七)财政金融；(八)农业；(九)工业；(十)建筑业；(十一)交通运输邮电通信业；(十二)批发零售与住宿餐饮业；(十三)对外经济贸易与旅游；(十四)科学、教育、文化与出版；(十五)体育、卫生与其他；(十六)能源；(十七)市县国民经济主要指标；(十八)企业概况。本年鉴各篇末附有《主要统计指标解释》，对主要统计指标的含义、统计范围和统计方法作了简要说明。

三、本年鉴按照现行国家统计制度，对个别历史统计资料作了调整和修订，凡此前我局发布的与本年鉴不一致的统计数据，均以本年鉴为准。由于2006年为第二次全国农业普查年，农业部分根据普查结果对近年数据做了较多调整，有些数据将在《福建统计年鉴—2009》中继续调整。

四、金门县统计资料除另有注明外，暂未列入本年鉴。

五、本年鉴重要统计数据的资料来源、计算口径等均在各篇另有注明。

六、本年鉴使用的度量衡单位均采用国家统一标准计量单位。

七、本年鉴部分数据由于单位取舍不同而产生的误差均未作调整。

八、本年鉴表中的符号使用如下：

“…”表示数据不足该指标最小单位数；

“空格”表示该项指标无数据；

“#”表示其中的主要项。

九、本年鉴工业部分“规模以上”工业企业系指年主营业务收入（或产品销售收入）500万元以上的法人工业企业；批发零售与住宿餐饮业部分“限额以上”批发零售与住宿餐饮业指年销售额2000万元及以上的批发企业（含外贸企业）、年销售额500万元及以上的零售企业、星级住宿企业和年营业额200万元及以上的餐饮企业。

十、本年鉴中GDP、农林牧渔业总产值、工业总产值等总量指标按当年价格计算，增长速度和产值指数按可比价格计算。

十一、本年鉴计算增长速度、指数均采用“水平法”。

十二、本年鉴中卫生部分2007年度数据为初步统计数。

## Preface

I . *Fujian Statistical Yearbook 2008* is an annual statistics publication, which covers very comprehensive data in 2007 and some selected data in previous years since 1949 at provincial and regional levels and in different departments and therefore, reflects various aspects of social and economic development in Fujian province.

II . The yearbook contains the following eighteen parts, 1. General Survey; 2. National Economy Accounting; 3. Population and Labor Force; 4. Investment in Fixed Assets; 5. People's Livelihood; 6. Price Indices; 7. Finance; 8. Agriculture; 9. Industry; 10. Construction; 11. Transportation, Postal and Telecommunication Services; 12. Wholesales, Retail Sales, Hotels and Catering Services; 13. Foreign Trade and International Tourism; 14. Science and Technology, Education, Culture and Publishing; 15. Sports, Public Health and Others; 16. Energy; 17. Main Economic Indicators of City Prefecture and County; 18. General Situation of Enterprises. In explanatory notes on main statistical indicators at the end of each part, the signification of main statistical indicators, statistical coverage and statistical methods are concerned.

III. Historical data in this yearbook are adjusted and revised according to current national statistical system thus the data in this yearbook should be regarded as standard when any difference between the data in this yearbook and those published before occurs. Because 2006 is the year of the second Agriculture census, many data of Agriculture in recent year have been adjusted according to the result of the census and some data will be continue to be adjusted in Fujian Statistics Yearbook 2009..

IV. The data of Jinmen county are not included in this yearbook except for some additional notes on it.

V. Data source, calculation scope for important statistical data in this yearbook are noted in each part.

VI. The units of measurement in this yearbook are internationally standard measurement units.

VII. Statistical discrepancies due to rounding are not adjusted in this yearbook.

VIII. Notations used in this yearbook:

“...” indicates that the figure is not large enough to be measured with the smallest unit in the item;

“(blank)” indicates that the data not available;

“#” indicates the major items of the total.

IX. Industrial enterprises above designated size in this yearbook refer to all corporative industrial enterprises with an annual major business income ( or product sale income) of over 5 million yuan; Enterprises above designated size in wholesale, retail sale, hotels and catering services refer to the wholesale enterprises (including foreign trade enterprises) with annual sales of over 20 million yuan, the retail enterprises with annual sales of over 5 million yuan, star-ranking hotels and the catering enterprises with annual turnover of over 2 million yuan respectively.

X. The indicator of GDP, gross output value of farming, forest, animal husbandry and fishery and industry in this yearbook is calculated according to prices of current year. Growth rate and indices of production value is calculated according to comparable prices.

XI. Growth rates and indices in this yearbook are calculated by “level approach”.

XII. The data of Public Helth in 2007 in this yearbook are preliminary statistical data.
