II. 编辑说明

一、《湖北统计年鉴—2009》是一本信息密集的资料工具书。通过大量数据,全面地收集、记载和反映了湖北省 2008 年经济、社会、科技、文化等方面的发展情况。具有信息量大、权威性强、适用性广等特点。

二、本年鉴包括综合、人口、从业人员和职工工资、固定资产投资、能源生产和消费、物价指数、人民生活、城市概况、农业、工业、建筑业、运输和邮电、国内外贸易、对外经济和旅游、财政、金融和保险业、教育、科技和文化、体育、卫生、社会福利、企业景气与监测、湖北省开发区主要经济指标、武汉城市圈、县市概况、附录等 22 个部分,城市概况部分系市区资料,不包括市辖县。

三、2009 年的湖北统计年鉴,对部分指标进行了调整改进,增加了分市州单位 GDP 能耗、电耗、单位工业增加值能耗等,因经济普查的原因,调减了工业部分指标。

四、本年鉴对过去发表的统计资料重新予以审核,凡与本年鉴资料有出入的,均以本年鉴为准。本年鉴中统计公报的数据为初步测算数,若与年鉴正文数据不一致,请以正文数据为准。

五、年鉴中指标的使用要结合文中的指标解释,以及注解合理使用,以免发生错误。

六、《湖北统计年鉴》公开出版以来,受到国内外读者的爱护与支持,对本年鉴的内容和编辑工作提出了许多宝贵意见,为此,我们特表谢意。由于水平有限,编辑工作中难免有疏误之处,竭诚欢迎读者批评指正。
