出版说明

《广东法院年鉴》是由广东省高级人民法院编辑出版的年刊，自 1998 年开始编印，2004 年开始公开出版。它旨在全面、系统地反映全省法院开展审判和执行工作、深化法院改革、加强队伍建设和物质装备建设等方面的基本情况，为社会各界了解法院工作提供基本资料。《广东法院年鉴》的编辑出版，是整理固定我省历史司法资料、促进法院审判工作不断发展的需要，是全省各级人民法院交流经验、了解信息的需要，是对外宣传法院工作成效、展示法院风采的重要窗口，也是我省乃至我国司法建设的重要组成部分。它具有资料性、宣传性和实用性。

《广东法院年鉴》2011 年刊的编写体例、风格和形式沿用 2010 年刊的模式，坚持图文并茂。在内容方面，更加注重宣传性、可读性和精练性，对重大案例、重要会议（包括领导讲话）等方面的内容，采取简介或综述的形式，不再全文刊登，部分内容也作了适当调整。全书共分五编。第一编《领导关怀与重要批示》，主要通过文字、图片等形式，简要介绍中央、省委、省人大和最高人民法院等领导视察我省法院工作的情况和所作的重要讲话，以及重要领导批示。第二编《全省法院工作》，全面反映全省法院 2011 年各项工作的基本情况，突出反映法院各项工作所取得的整体成效，重点介绍全省法院在审判、执行、改革、基层建设、队伍建设和司法服务等方面的突出成效及主要做法。第三编《省法院工作》，集中反映省法院各项工作的基本情况，重点反映省法院各项工作取得的成效，简要介绍省法院各部门工作的基本情况和全省法院重大会议、重大活动、重大案例及重要文件，附有 2011 年 1 月省法院向省人大所作的工作报告、省法院领导及各部门领导名录。第四编《各中级法院工作》，主要以图片和文字形式分地区反映各中院及部分基层法院工作的基本情况、法官的精神风貌及所取得的突出成绩，附有全省各中级法院和基层法院院长名录，以及截至 2011 年底的全省人民法庭名录。第五编《争当排头兵专项活动》反映广东省各级法院 2008—2011 年争当排头兵活动取得的突出成绩、经验总结及社会评价。

本年鉴在编辑出版过程中，得到了省法院各位院领导、各部门及各中级法院的关心和支持，得到了广东人民出版社的支持和协助，谨在此表示感谢！本书疏漏和不当之处，敬请批评指正。
