



要在已有较好基础上继续把税收事业推向前进。一 是安下心来干工作。总的是要处理好连续稳定与改革发 展的关系。根据形势发展变化,把党中央、国务院的新 要求落实好,与时俱进,开拓创新,实现税收事业新的 发展。二是用起心来搞改革。改革是我国发展最大的红 利。本届政府是改革的政府。税制改革时不我待,十分 紧迫,必须加快推进。三是聚起心来谋发展。营造团结 和谐的干事氛围、搭建干部施展才能的发展平台、形成 团结奋进的工作局面。

当前要扎实抓好几项重点工作。一要进一步深入 学习贯彻中央一系列大政方针和国务院领导同志的指示 要求,做好全国"两会"提案和建议的办理工作,及时 回应代表、委员的关切, 研究解决好社会关注的税收热 点问题。二要抓好税收收入及一季度情况的分析工作, 分析要有深度,有特色,有独到之处。三要转变职能改 进作风, 规范运转程序, 提高行政效率, 树立税务部门 良好的社会形象。四要加强税务干部队伍建设, 倾情带 队,既要关心干部的生活,又要关心干部的成长。五要 强力推进党风廉政建设,坚持严格要求、严格教育、严 格管理、严格监督,促进干部廉洁从税。要结合行业特 点,提出税务部门的"约法三章"。

# 2013年一季度全国税收收入情况分析

Analysis of Tax Revenue Collected Nationwide in the First Quarter of 2013

2013年一季度,全国税收收入 累计完成29419亿元,比上年同期 增长3%,增收867亿元。其中税务 部门组织收入26463亿元,同比增 长8.4%,增收2052亿元;海关代 征进口税收2957亿元,同比下降 28.6%,减收1185亿元。全国共办 理出口退税2577亿元,同比增长 1.6%,增加40亿元。此外,税务部 门还组织征收社会保险费、教育 费附加、文化事业建设费等其他 收入3787亿元,同比增长9.7%,增 收334亿元。

# 一、税收增长与经济发展基本协调,呈现 平稳增长态势

一季度全国税收收入增长3%,其中1、2、3月份分别增长2.5%、2.1%和4.8%。若不含海关代征进口税收,税务部门组织的税收收入增长8.4%,一季度国内生产总值(GDP)增长7.7%,税收与经济发展基本协调;其中1、2、3月份分别增长8.6%、7.9%和8.6%,税收收入增长总体平稳。

# 二、海关代征进口税收大幅下降,地方级 税收增长快于中央级

一季度中央级税收完成15925亿元,同比下降4.5%,其中海关代征进口税收同比下降28.6%,扣除海关代征进口税收后的中央级税收同比增长3.5%;地方级税收完成13494亿元,同比增长13.6%,地方级税收增长快于中央级10.1个百分点。在地方级税收收入中,省、市、县三级收入分别完成2929亿元、3890亿元和6675亿元,分别增长13.3%、9.7%和16.1%。

# 三、大部分主体税种低幅增长,财产行为 税收入增长突出

一季度,国内货物劳务税(不含海关代征进口税收)完成14644亿元,同比增长7.9%,其中国内增值税、国内消费税、营业税和车购税分别增长5.8%、2.3%、14.3%和9.3%;所得税完成7359亿元,同比增长4.4%,其中企业所得税和个人所得税分别增长2.7%和9.1%;财产行为税增长突出,完成4459亿元,同比增长17.8%,大大高于货物劳务税和所
