序一

当前，我国规划行业正处于规划体系的变革期，上海也步入了《上海市城市总体规划（2017—2035年）》实施的关键期。今年，陆昊部长在调研上海规划工作时强调，要进一步加强规划编制的科学性。在第七次上海市规划土地工作会议上，李强书记提出，要全面贯彻落实习近平总书记考察上海重要讲话精神，紧紧围绕发展第一要务，深入推进新一轮城市总体规划实施，为加快建设具有世界影响力的社会主义现代化国际大都市提供有力支撑；应勇市长指出，要不断完善规划实施保障机制，强化政策创新、监测评估、法治保障，明确责任、形成合力，确保“一张蓝图干到底”。

近年来，上海以新一轮城市总体规划的编制和实施为契机，着力推进城乡规划工作转型，在城乡规划体系、城市有机更新、城市设计、公众参与等方面开展了许多有益的创新实践。上海的城乡规划工作始终坚持以人民为中心，坚持可持续发展，坚持人与自然和谐共生，坚持在发展中保障和改善民生，坚持体现国家战略要求、城市发展诉求和市民生活需求。

2017年度上海优秀城乡规划设计奖评选，充分体现了五大发展理念，全面展现了近年上海城乡规划编制在理念、技术、方法上的探索与创新。如全国首个街道设计标准《上海市街道设计导则》，从人的需求视角出发，围绕安全、绿色、活力、智慧四大导向提出目标策略体系，有力推动了上海街道空间的“人性化”转型；《上海市黄浦江两岸公共空间贯通开放规划》立足“还江于民”，从黄浦江全线的整体视角审视两岸地区发展，从城市整体发展的全局高度进一步完善功能布局，努力打造世界级滨水开放空间，为市民群众提供更多环境好、品质高的公共活动空间。这些优秀的规划设计成果有效地促进了城市转型提质，为全市乃至全国规划行业发展提供了有益经验。

为更好地总结和展现上海城乡规划设计的新理念、新技术和新实践，在中国城市规划协会的关注和支持下，上海市城市规划行业协会在每次评奖结束后，针对其中编制水平较高、具有创新理念和特色的获奖项目，邀请专家点评，并每两年出版一本获奖作品集。这已成为上海规划行业品牌建设的重要内容，并获得了较好的业内评价和社会反响。本次作品集收录了130个项目，包括2017年度上海

市优秀城乡规划设计奖 119 项，以及由本市规划设计单位参与编制并通过外省市规划协会申报获全国奖 11 项，项目类型多样、内容丰富，集中展示了近年来上海规划设计单位的优秀规划成果。

在构建国土空间规划体系的新形势下，上海规划工作将继续围绕中央和市委、市政府的工作部署，进一步发挥规划的引领力和管控力，聚焦“上海 2035 总规”实施、长三角一体化发展、自贸区新片区建设、黄浦江苏州河沿岸规划建设、城市有机更新和旧区改造、乡村振兴等重点任务，对标国际最高标准、最好水平，以高标准、高水平的规划设计，为上海高质量发展服务，为建设“创新之城、人文之城、生态之城”服务。

FOREWORD I

China's planning industry is experiencing a reform of the planning system, while Shanghai has entered a critical period for the implementation of the *Shanghai Urban Master Plan (2017—2035)*. This year, Minister Lu Hao stressed in his investigation of Shanghai planning work that it is necessary to further strengthen the scientific nature of planning. At the Seventh Shanghai Planning and Land Work Conference, Shanghai Municipal Secretary of CCPC Li Qiang put forward that we should fully implement the spirit of General Secretary Xi Jinping's important speech on his inspection of Shanghai, closely focus on the development of the first priority, and further promote the implementation of a new round of urban master plan, so as to provide strong support for speeding up the construction of a modern socialist international metropolis with world influence. Besides, Mayor Ying Yong pointed out that it is required to constantly improve the safeguard mechanism for the planning implementation, strengthen policy innovation, monitoring and evaluation, and guarantee the legal system, and clarify responsibilities, so as to form joint force to ensure that a set of blueprints is carried through to the end.

In recent years, taking the opportunity of planning and implementing a new round of urban master plan, Shanghai has made great efforts to promote the transformation of urban and rural planning work, and carried out beneficial innovative practice in respects of urban-rural planning system, urban organic renewal, urban design and public participation. The city's urban and rural planning work always adheres to the people-centered principle, persists in sustainable development, upholds the harmonious coexistence of human and nature, insists on safeguarding and improving people's livelihood in development, and embodies the national strategic demands, the urban development appeals and the citizens' livelihood needs.

The selection activity of Shanghai Excellent Urban-Rural Planning and Design Award-winning Works, 2017 perfectly reflects the five major development concepts, and comprehensively displays the exploration and innovation in the conception, technology and methodology of Shanghai urban and rural planning in recent years. For example, "*Shanghai Sub-District Design Guidelines*", the first sub-district design standard in the country, puts forward the target strategy system based on the objectives of safety, green, vitality and wisdom, which effectively promotes the "humanized" transformation of sub-district urban space. For another example, "*Opening and Run-Through Plan for Public Space on Both Sides of Huangpu River*", for the purpose of the "returning the riverside to the people", examines the development of both sides of the river from the holistic perspective of the entire Huangpu

River, and further improves the functional layout from the overall height of the city's holistic growth, and strives to build up a world-class waterfront open space, in order to offer more public activity spaces with good environment and high quality for the citizens. Such excellent planning and design achievements would effectively promote the urban transformation and quality upgrading, and provide useful experience for the development of the city's and even the national planning industry.

In order to better summarize and display new conception, new technology and new practice of the city's urban-rural planning and design industry, Shanghai Urban Planning Trade Association (SUPTA), with the concern and support of China Association of City Planning (CACCP), would invite experts after each selection activity to make comments and explanations for some award-winning projects with high level of planning, innovative ideas and distinctive features, and publish a collection of award-winning works every two years. *Collection of Works* has become an important part of the brand building task of Shanghai planning industry, and has received very positive professional appraisal and social response. The *Collection of Works* released this year contains 130 projects, including 119 projects with 2017's Shanghai excellent urban-rural planning and design awards, and 11 national award-winning projects participated in by Shanghai planning and design institutions and recommended by urban-rural planning associations of other provinces and cities. Therefore, this *Collection* contains a variety of project types with rich contents, which centrally shows the excellent planning results made by Shanghai planning and design institutions in recent years.

In the new situation of constructing a spatial planning system, Shanghai's planning work will continue to carry out the work drawn up by CPC Central Committee and State Council as well as Shanghai CPC Municipal Committee and Municipal Government, further play a role of strategic guidance and administrative control of the planning work. We will focus on the following key tasks: implementation of the "Shanghai 2035 Master Plan", integrated development of the Yangtze River Delta, construction of new area in Free Trade Zone, planning and construction of the riversides along Huangpu River and Suzhou Creek, organic renewal of the city and the renovation of the old districts, revitalization strategy for rural areas, etc. Benchmarking the strictest criteria and highest level in the world, we will provide high-criteria, high-level planning and design to serve the high-quality development of Shanghai — a City of "Innovation, Humanities and Ecology".

序二

两年一度的上海优秀城乡规划设计奖评选，是对广大规划设计单位最新成果的检阅和展示，集中反映了一定时期内上海城乡规划编制工作的丰硕成果，也是规划工作者求真务实、勤奋敬业、辛勤努力的整体业绩。

回顾 2009 年以来十年共五届上海优秀城乡规划设计奖的评选，申报数量逐届增多，总体质量不断提高，编制内容紧跟时代步伐，充分展现了多年来上海规划编制和研究工作的积极探索和创新实践。

在市规划资源局领导的重视和关心下，2017 年度上海规划评优共收到 65 家规划设计及勘测、信息单位报送的 313 个项目。经专家组评审，评选出特等奖 1 项、一等奖 14 项、二等奖 33 项、三等奖 63 项。2018 年 10 月，经中国城市规划协会组织的三轮评审，由上海市城市规划行业协会推荐的 47 个项目，最终有 27 个项目在全国获奖。其中，《上海市城市总体规划（2017—2035 年）》《上海市街道设计导则》和《上海市黄浦江两岸公共空间贯通开放规划》等 7 个项目荣获全国一等奖，创历史新高。这些不同类型的规划成果内容丰富、各具特色，充分体现了中央新发展理念与地方实际的紧密结合，更加重视理念创新和技术创新，坚持前瞻性和可操作性相结合，发挥了很好的示范和引领作用，在规划领域引起广泛关注，受到了广大规划工作者的欢迎和赞誉。

在中国城市规划协会的关注和广大会员单位的支持下，上海市城市规划行业协会把本届在全国和上海获奖的 130 个优秀规划作品汇编成集，并邀请业内资深专家对部分获奖作品作了点评。这些优秀规划项目反映出诸多特点和亮点，主要是：

一、落实国家战略和新发展理念，明晰上海城市发展目标，优化和提升城市功能定位，提出了建设卓越的全球城市，紧密对接“两个一百年”的宏伟目标，有利于振奋人心、凝聚力量。

二、坚持以人民为中心，反映广大市民期盼，见物又见人，更加注重生态文明和绿色发展，充分发挥城乡规划的公共政策属性。

三、从以往重视规划的引领作用，到现在更加关注底线管控，坚守土地资源、人口规模、生态环境、

城市安全底线，同时有明确的实施年限和控制指标，以利于全社会的监督和考核。

四、加强历史文化保护，弘扬城市精神和特色风貌，进一步健全适应上海发展实际的“点、线、面”相结合的保护体系。

五、坚持“开门编规划”，鼓励公众参与，倾听民声、汇聚民智，使城市总体规划更接地气。

六、更加注重规划的“管用”“高效”，既通过“1+3”成果体系，确保市、区总规层层落地，同时又积极推进“多规合一”，有利于把规划蓝图变成美好现实。

当前，面对国家机构改革和重构国土空间规划体系的新形势、新任务，对于整个规划行业而言，机遇大于挑战。面对新发展、新要求，我们要深入学习，认真领会中央文件精神，把实施“上海2035总规”和构建国土空间规划体系深度融合，更好地服务于上海高质量发展、高品质生活。

上海市城市规划行业协会将继续努力，认真落实上海市委、市政府和市规划资源局的总体部署和工作要求，发挥好桥梁和纽带作用，与广大规划设计单位一起，共同为建设卓越的全球城市，为建设“五个中心”和社会主义现代化国际大都市，作出应有的一份贡献。

FOREWORD II

The biennial selection of excellent urban-rural planning and design award-winning works is a review and display of the latest achievements of the planning and design institutions in Shanghai, centrally reflecting the fruitful results of the city's urban-rural planning work in a certain period of time. These outstanding works represent the comprehensive level of Shanghai's planning and design teams and are also the overall performance of all planners' practicality, dedication and diligence.

When looking back the five selection activities in the past ten years since 2009, we are delighted to see that the number of applications has increased year by year. The overall quality has been continuously improved, and the planning content has kept up with the times, fully demonstrating the years' of positive exploration and innovative practice of planners and researchers in Shanghai.

With more attention and concern of the leaders of the Shanghai Municipal Planning & Resources Bureau, the selection activity of 2017 in Shanghai received a total of 313 projects submitted by 65 planning & design, and survey & information institutions. One Special Prize, 14 First Prizes, 33 Second Prizes and 63 Third Prizes were selected from 313 projects after the evaluation by the expert groups. In October 2018, after three rounds of evaluation organized by China Association of City Planning (CACP), 47 projects were recommended by the Shanghai Urban Planning Trade Association (SUPTA), and 27 projects won National Awards. 7 of them, including “*Shanghai Urban Master Plan (2017–2035)*”, “*Shanghai Sub-District Design Guidelines*” and “*Opening and Run-Through Plan for Public Space on Huangpu Riversides*” won the first national prize, reaching a record high. These different types of planning works show a variety of ideas with their own unique features, fully embodying the close combination of the new development concepts advocated by the central government with the reality in localities, and have paid more attention to the concept innovation and technological innovation. The works keep the integration of farsightedness and operability, and thus play a very good role in demonstration and guidance, which attract extensive attention in the planning field, and are welcomed and praised by the majority of planners.

With the CACP's concern and the support of its member institutions, SUPTA has compiled 130 outstanding planning works that won prizes in the country and Shanghai this year. We invited senior experts to make comments on some of the winning works, which can reflect new features and highlights, mainly as follows:

- A. the national strategy and the new development concept are implemented to embody Shanghai's urban development goals and optimize and upgrade the orientation of the city's functions; the construction of an outstanding "Global City" is proposed and closely linked to the "two centennial" goals to inspire people and gather strength.
- B. the people-centered principle is upheld to reflect the expectations of the general public and care both things and people; ecological civilization and green development are emphasized to fully reveal the public policy attributes of urban and rural planning.
- C. our focus is shifted from the previous strategic guidance of planning work to the bottom line control of land resources, population size, ecological environment and urban safety; at the same time there should be clear time limit to project implementation and control indicators to facilitate the management and assessment.
- D. the protection of history and culture should be enhanced, to improve the urban spirit, feature and style, and further construct combined "Point-line-surface" protection system that adapts to the actual development of Shanghai.
- E. planning work is insisted on with door opened to encourage public participation and listen to the people, gather their wisdom, so as to make the city's master plan closer to the ordinary people.
- F. the effectiveness and efficiency of planning are paid more attention to, which not only ensures that each planning at the city or district level is implemented through the "1+3" result system, but also helps to turn blueprints into reality by actively promoting the "multi-planning integration".

We are in a new situation, facing the requirements of the national institutional reform and the reconstruction of the spatial planning system, in which there is more opportunity than challenge for the entire planning industry. In front of a new round of development, we should study in depth, grasp the spirit of the central committee documents and implement the General Regulation of "Shanghai 2035" Master Plan and build a deep integration of land and space planning system to better serve Shanghai's high-quality development and high-quality life.

SUPTA will continue to work hard, conscientiously implement the overall deployment and specific requirements by Shanghai Municipal Party Committee and Municipal Government, and play the role as a bridge and link. SUPTA will make due contributions, together with the vast number of planning and design institutions, to the planning and construction of an outstanding global city, and a modern socialist international metropolis with "Five Centers".

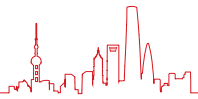

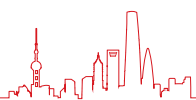
