前言

参加过或正在准备参加全国硕士研究生入学统一考试的考生都知道，词汇在考研英语中占有举足轻重的分量，同时也会从不同渠道得到这样一条建议：“一定要多多阅读与命题素材同源的文章，在真实的语境中记忆词汇。”一般而言，这个建议是有一定道理的。但是，处于备考状态的考生，没有时间按部就班地学习与记忆词汇，本来有道理的学习方法在这一特殊阶段就显得不那么合理了。我们知道，历年真题试卷都集中体现了考研英语的命题原则和整体思路，同时也真实地体现了命题人在命制试题时的语言风格与选词特征。更重要的是，每一套真题都在重复着考试大纲所圈定的标准词汇。既然如此，我们为什么要舍近求远，为什么不去直接研读真题呢？

这是每一位考生都应该想清楚的问题。显然，真题，特别是真题所给出的题目（含题干和选项），为有效记忆大纲核心词汇提供了最好的记忆语境。我们只要分析一下 2015 年和 2014 年的真题，这一道理便一目了然了。

我们先看一下 2015 年考研英语真题中的一个例子：

[原文] ... But embarrassing scandals and the popularity of the republican left in the recent Euro-elections have forced him to eat his words and **stand down**...

[题干] According to the first two paragraphs, King Juan Carlos of Spain _____

[答案] [D] **ended his reign** in embarrassment.

（阅读理解 A 节，Text 1，第 21 题）

这个题目所涉及的核心词汇分别是原文的 stand down（从高职位退下）以及正确答案中的 reign（君权，统治），而选项中“结束统治”的表述正是对原文中“退位”这一细节信息的近义解释。

再看另外一个例子：

[题目] The United States is the product of two **principal** forces—the **immigration** of European peoples with their **varied** ideas, **customs** and national **characteristics** and the **impact** of a new country which **modified** these **traits**.

[答案] 美国是两股主要力量相互作用的产物，一是具有不同思想、习俗、民族特质的欧洲各民族的迁入，二是一个新国度因改变了这些特征而产生的影响。

（阅读理解 C 节，第 47 题）

从结构上看，这个句子并不复杂，破折号前面的句子主干是个简单句，后面的两个名词短

语解释了主干句中提到的 two principal forces (两股力量)。但是, 尽管句子结构比较简单, 如果考生不熟悉句中的重点词汇, 完成本句的翻译任务就无从谈起。

以上两个从真题中随手撷取的例子充分显示了考研英语大纲词汇的考查特点, 即:

—— 试卷题目尽可能多地覆盖大纲词汇

—— 题干和选项中所用词汇难度级别更高

根据考研英语词汇考查的基本特点, 也根据多年的全国考研英语命题经验, 我们为广大考生特意编写了这本《考研英语最新两套真题 + 真题必现词汇 3500 便携速记》。这本书主要体现了以下三个核心理念:

(一) 聚焦核心词汇, “先知新, 后温故”, 少做无用功

考研英语(一)大纲词汇中的 5500 个单词包括了中学阶段优秀水平的 3500 个单词和大学阶段公共英语水平的 2000 个单词。为了便于考生提高备考效率, 本书锁定了常考的 500 个中学阶段高阶单词、2000 个大学阶段核心单词以及 1000 个重点衍生词, 共计 3500 个左右。如此压缩后, 词汇记忆的范围大大缩减, 考生更容易将注意力集中在熟悉程度尚低, 但与试题相关度更高的词汇上。我们需要提醒大家, 将新旧单词混在一起复习, 表面看来似乎可以温故而知新, 但实际上, 注意力会不自觉地被已经掌握的单词分散, 精力的不集中会阻碍对陌生单词的理解与吸收。因此, “先知新, 后温故”才是更有效的基本策略, 也就是说, 先集中精力记忆核心生词, 之后再做全面复习。

(二) 以真题为词汇记忆语境, 以题目为核心语境, 借助微课深入理解词汇与真题的关系

本书的“真题解析”部分尤其突出了词汇内容, 希望考生能够理解我们的苦心, 充分利用这一编写安排的优势, 在真题语境中有效学习并记忆词汇。本书为各位考生配备的视频微课, 当能帮助大家更深入地理解大纲词汇与真题的关系。

(三) 随身携带, 随时随地记忆词汇, 注重不同时段重复记忆

二语习得的研究成果显示, 如果在六到八个不同的时间段重复记忆某一语言细节, 更容易在学习者的头脑中形成深刻的印象。与其反复记忆某一个或某一组词汇, 不如将“记住几个”的心理期待调整为“覆盖更多”, 即每次力争多浏览, 但不强求一定记牢, 这样, 在不同时间段中多重复几次, 自然就都记住了。这本《考研英语最新两套真题 + 真题必现词汇 3500 便携速记》

的编写目的，就是希望考生在备考期间，能够将这本小书带在身边，充分利用碎片时间增加重复记忆的次数，以不断巩固学习成果。

总之，词汇的有效把握是顺利通过硕士研究生入学考试并取得好成绩的基础。备考过程中，大家一定不要觉得不背单词也可以做题，解题思路和解题技巧只有在词汇过关的基础上才能发挥作用。因此，我们衷心希望，这本《考研英语最新两套真题 + 真题必现词汇 3500 便携速记》能够为考生指明复习方向，划定词汇备考范围，减轻压力，提高效率。我们也衷心希望大家少受不必要的干扰，少一分焦虑和自责情绪，凭借清晰的思路和踏实的努力，不断取得进步。考研路途中，没有无法突破的瓶颈，只要努力，每一位考生都会顺利闯过词汇这道难关。

Though not biologically related, friends are as “related” as fourth cousins, sharing about 1% of genes. That is 1 a study published from the University of California and Yale University in the *Proceedings of the National Academy of Sciences*, has 2.

The study is a genome-wide analysis conducted 3 1,932 unique subjects which 4 pairs of unrelated friends and unrelated strangers. The same people were used in both 5.

While 1% may seem 6, it is not so to a geneticist. As James Fowler, professor of medical genetics at UC San Diego, says, “Most people do not even 7 their fourth cousins but somehow manage to select as friends the people who 8 our kin.”

The study 9 found that the genes for smell were something shared in friends but not genes for immunity. Why this similarity exists in smell genes is difficult to explain, for now. 10, as the team suggests, it draws us to similar environments but there is more 11 it. There could be many mechanisms working together that 12 us in choosing genetically similar friends 13 “functional kinship” of being friends with 14!

One of the remarkable findings of the study was that the similar genes seem to be evolving 15 than other genes. Studying this could help 16 why human evolution picked pace in the last 30,000 years, with social environment being a major 17 factor.

The findings do not simply explain people’s 18 to befriend those of similar 19 backgrounds, say the researchers. Though all the subjects were drawn from a population of European extraction, care was taken to 20 that all subjects, friends and strangers were taken from the same population. The team also controlled the data to check ancestry of subjects.

Text 1

King Juan Carlos of Spain once insisted “kings don’t abdicate, they die in their sleep.” But embarrassing scandals and the popularity of the republican left in the recent Euro-elections have forced him to eat his words and stand down. So does the Spanish crisis suggest that monarchy is seeing its last days? Does that mean the writing is on the wall for all European royals, with their magnificent uniforms and majestic lifestyles?

The Spanish case provides arguments both for and against monarchy. When public opinion is particularly polarized, as it was following the end of the Franco regime, monarchs can rise above “mere” politics and “embody” a spirit of national unity.

It is this apparent transcendence of politics that explains monarchs’ continuing popularity as heads of state. And so, the Middle East excepted, Europe is the most monarch-infested region in the world, with 10 kingdoms (not counting Vatican City and Andorra). But unlike their absolutist counterparts in the Gulf and Asia, most royal families have survived because they allow voters to avoid the difficult search for a non-controversial but respected public figure.

Even so, kings and queens undoubtedly have a downside. Symbolic of national unity as they

claim to be, their very history – and sometimes the way they behave today – embodies outdated and indefensible privileges and inequalities. At a time when Thomas Piketty and other economists are warning of rising inequality and the increasing power of inherited wealth, it is bizarre that wealthy aristocratic families should still be the symbolic heart of modern democratic states.

The most successful monarchies strive to abandon or hide their old aristocratic ways. Princes and princesses have day-jobs and ride bicycles, not horses (or helicopters). Even so, these are wealthy families who party with the international 1%, and media intrusiveness makes it increasingly difficult to maintain the right image.

While Europe's monarchies will no doubt be smart enough to survive for some time to come, it is the British royals who have most to fear from the Spanish example.

It is only the Queen who has preserved the monarchy's reputation with her rather ordinary (if well-heeled) granny style. The danger will come with Charles, who has both an expensive taste of lifestyle and a pretty hierarchical view of the world. He has failed to understand that monarchies have largely survived because they provide a service – as non-controversial and non-political heads of state. Charles ought to know that as English history shows, it is kings, not republicans, who are the monarchy's worst enemies.

Text 2

Just how much does the Constitution protect your digital data? The Supreme Court will now consider whether police can search the contents of a mobile phone without a warrant if the phone is on or around a person during an arrest.

California has asked the justices to refrain from a sweeping ruling, particularly one that upsets the old assumption that authorities may search through the possessions of suspects at the time of their arrest. It is hard, the state argues, for judges to assess the implications of new and rapidly changing technologies.

The court would be recklessly modest if it followed California's advice. Enough of the implications are discernable, even obvious, that the justices can and should provide updated guidelines to police, lawyers and defendants.

They should start by discarding California's lame argument that exploring the contents of a smartphone – a vast storehouse of digital information – is similar to, say, going through a suspect's purse. The court has ruled that police don't violate the Fourth Amendment when they go through the wallet or pocketbook of an arrestee without a warrant. But exploring one's smartphone is more like entering his or her home. A smartphone may contain an arrestee's reading history, financial history, medical history and comprehensive records of recent correspondence. The development of "cloud computing," meanwhile, has made that exploration so much easier.

Americans should take steps to protect their digital privacy. But keeping sensitive information on these devices is increasingly a requirement of normal life. Citizens still have a right to expect private documents to remain private and protected by the Constitution's prohibition on unreasonable searches.

As so often is the case, stating that principle doesn't ease the challenge of line-drawing. In many cases, it would not be overly onerous for authorities to obtain a warrant to search through phone contents. They could still invalidate Fourth Amendment protections when facing severe, urgent circumstances, and they could take reasonable measures to ensure that phone data are not erased or altered while a warrant is pending. The court, though, may want to allow room for police to cite situations where they are entitled to more freedom.

But the justices should not swallow California's argument whole. New, disruptive technology sometimes demands novel applications of the Constitution's protections. Orin Kerr, a law professor, compares the explosion and accessibility of digital information in the 21st century with the establishment of automobile use as a digital necessity of life in the 20th: The justices had to specify novel rules for the new personal domain of the passenger car then; they must sort out how the Fourth Amendment applies to digital information now.

Text 3

The journal *Science* is adding an extra round of statistical checks to its peer-review process, editor-in-chief Marcia McNutt announced today. The policy follows similar efforts from other journals, after widespread concern that basic mistakes in data analysis are contributing to the irreproducibility of many published research findings.

"Readers must have confidence in the conclusions published in our journal," writes McNutt in an editorial. Working with the American Statistical Association, the journal has appointed seven experts to a statistics board of reviewing editors (SBoRE). Manuscript will be flagged up for additional scrutiny by the journal's internal editors, or by its existing Board of Reviewing Editors or by outside peer reviewers. The SBoRE panel will then find external statisticians to review these manuscripts.

Asked whether any particular papers had impelled the change, McNutt said, "The creation of the 'statistics board' was motivated by concerns broadly with the application of statistics and data analysis in scientific research and is part of *Science*'s overall drive to increase reproducibility in the research we publish."

Giovanni Parmigiani, a biostatistician at the Harvard School of Public Health, a member of the SBoRE group, says he expects the board to "play primarily an advisory role." He agreed to join because he "found the foresight behind the establishment of the SBoRE to be novel, unique and likely to have a lasting impact. This impact will not only be through the publications in *Science* itself, but hopefully through a larger group of publishing places that may want to model their approach after *Science*."

John Ioannidis, a physician who studies research methodology, says that the policy is "a most welcome step forward" and "long overdue." "Most journals are weak in statistical review, and this damages the quality of what they publish. I think that for the majority of scientific papers nowadays

statistical review is more essential than expert review,” he says. But he noted that biomedical journals such as *Annals of Internal Medicine*, the *Journal of the American Medical Association* and *The Lancet* pay strong attention to statistical review.

Professional scientists are expected to know how to analyze data, but statistical errors are alarmingly common in published research, according to David Vaux, a cell biologist. Researchers should improve their standards, he wrote in 2012, but journals should also take a tougher line, “engaging reviewers who are statistically literate and editors who can verify the process.” Vaux says that *Science*’s idea to pass some papers to statisticians “has some merit, but a weakness is that it relies on the board of reviewing editors to identify ‘the papers that need scrutiny’ in the first place.”

Text 4

Two years ago, Rupert Murdoch’s daughter, Elisabeth, spoke of the “unsettling dearth of integrity across so many of our institutions.” Integrity had collapsed, she argued, because of a collective acceptance that the only “sorting mechanism” in society should be profit and the market. But “it’s us, human beings, we the people who create the society we want, not profit.”

Driving her point home, she continued: “It’s increasingly that the absence of purpose, of a moral language within government, media or business could become one of the most dangerous goals for capitalism and freedom.” This same absence of moral purpose was wounding companies such as News

International, she thought, making it more likely that it would lose its way as it had with widespread illegal telephone hacking.

As the hacking trial concludes – finding guilty one ex-editor of the *News of the World*, Andy Coulson, for conspiring to hack phones, and finding the predecessor, Rebekah Brooks, innocent of the same charge – the wider dearth of integrity still stands. Journalists are known to have hacked the phones of up to 5,500 people. This is hacking on an industrial scale, as was acknowledged by Glenn Mulcaire, the man hired by the *News of the World* in 2001 to be the point person for phone hacking. Others await trial. This long story still unfolds.

In many respects, the dearth of moral purpose frames not only the fact of such widespread phone hacking but the terms on which the trial took place. One of the astonishing revelations was how little Rebekah Brooks knew of what went on in her newsroom, how little she thought to ask and the fact that she never inquired how the stories arrived. The core of her successful defence was that she knew nothing.

In today's world, it has become normal that well-paid executives should not be accountable for what happens in the organizations that they run. Perhaps we should not be so surprised. For a generation, the collective doctrine has been that the sorting mechanism of society should be profit. The words that have mattered are efficiency, flexibility, shareholder value, business-friendly, wealth generation, sales, impact and, in newspapers, circulation. Words degraded to the margin have been justice, fairness, tolerance, proportionality and accountability.

The purpose of editing the *News of the World* was not to promote reader understanding, to be fair in what was written or to betray any common humanity. It was to ruin lives in the quest for circulation and impact. Ms Brooks may or may not have had suspicions about how her journalists got their stories, but she asked no questions, gave no instructions – nor received traceable, recorded answers.

Conceived in this way, comprehension will not follow exactly the same track for each reader. What is in question is not the retrieval of an absolute, fixed or “true” meaning that can be read off and checked for accuracy, or some timeless relation of the text to the world. (43) _____

Such background material inevitably reflects who we are. (44) _____ This doesn’t, however, make interpretation merely relative or even pointless. Precisely because readers from different historical periods, places and social experiences produce different but overlapping readings of the same words on the page – including for texts that engage with fundamental human concerns – debates about texts can play an important role in social discussion of beliefs and values.

How we read a given text also depends to some extent on our particular interest in reading it. (45) _____ Such dimensions of reading suggest – as others introduced later in the book will also do – that we bring an implicit (often unacknowledged) agenda to any act of reading. It doesn’t then necessarily follow that one kind of reading is fuller, more advanced or more worthwhile than another. Ideally, different kinds of reading inform each other, and act as useful reference points for and counterbalances to one another. Together, they make up the reading component of your overall literacy, or relationship to your surrounding textual environment.

[A] Are we studying that text and trying to respond in a way that fulfills the requirement of a given course? Reading it simply for pleasure? Skimming it for information? Ways of reading on a train or

in bed are likely to differ considerably from reading in a seminar room.

- [B] Factors such as the place and period in which we are reading, our gender, ethnicity, age and social class will encourage us towards certain interpretations but at the same time obscure or even close off others.
- [C] If you are unfamiliar with words or idioms, you guess at their meaning, using clues presented in the context. On the assumption that they will become relevant later, you make a mental note of discourse entities as well as possible links between them.
- [D] In effect, you try to reconstruct the likely meanings or effects that any given sentence, image or reference might have had: These might be the ones the author intended.
- [E] You make further inferences, for instance, about how the text may be significant to you, or about its validity – inferences that form the basis of a personal response for which the author will inevitably be far less responsible.
- [F] In plays, novels and narrative poems, characters speak as constructs created by the author, not necessarily as mouthpieces for the author's own thoughts.
- [G] Rather, we ascribe meanings to texts on the basis of interaction between what we might call textual and contextual material: between kinds of organization or patterning we perceive in a text's formal structures (so especially its language structures) and various kinds of background, social knowledge, belief and attitude that we bring to the text.

Part C

Within the span of a hundred years, in the seventeenth and early eighteenth centuries, a tide of emigration – one of the great folk wanderings of history – swept from Europe to America. (46) This movement, driven by powerful and diverse motivations, built a nation out of a wilderness and, by its nature, shaped the character and destiny of an uncharted continent.

(47) The United States is the product of two principal forces – the immigration of European peoples with their varied ideas, customs and national characteristics and the impact of a new country which modified these traits. Of necessity, colonial America was a projection of Europe. Across the Atlantic came successive groups of Englishmen, Frenchmen, Germans, Scots, Irishmen, Dutchmen, Swedes, and many others who attempted to transplant their habits and traditions to the new world. (48) But the force of geographic conditions peculiar to America, the interplay of the varied national groups upon one another, and the sheer difficulty of maintaining old-world ways in a raw, new continent caused significant changes. These changes were gradual and at first scarcely visible. But the result was a new social pattern which, although it resembled European society in many ways, had a character that was distinctly American.

(49) The first shiploads of immigrants bound for the territory which is now the United States

crossed the Atlantic more than a hundred years after the 15th- and 16th-century explorations of North America. In the meantime, thriving Spanish colonies had been established in Mexico, the West Indies, and South America. These travelers to North America came in small, unmercifully overcrowded craft. During their six- to twelve-week voyage, they survived on barely enough food allotted to them. Many of the ships were lost in storms, many passengers died of disease, and infants rarely survived the journey. Sometimes storms blew the vessels far off their course, and often calm brought unbearably long delay.

To the anxious travelers the sight of the American shore brought almost inexpressible relief, said one recorder of events, "The air at twelve leagues' distance smelt as sweet as a new-blown garden." The colonists' first glimpse of the new land was a sight of dense woods. (50) The virgin forest with its richness and variety of trees was a real treasure-house which extended from Maine all the way down to Georgia. Here was abundant fuel and lumber. Here was the raw material of houses and furniture, ships and potash, dyes and naval stores.
