PREFACE

As programs develop for research in Chinese law, the need for an inventory of the principal resource material - books - becomes obvious. At no one center have the books dealing with the law of China been gathered; at no one center is the current scholarly activity concentrated. Researchers at one institution have insufficient knowledge of the holdings of other institutions. This Preliminary Union List is an attempt to provide an inventory of twenty-one of the major library collections of Chinese legal materials. It is clearly a preliminary list because the scholarly evaluation of collections and the technical editing of catalog entries and translations have not been attempted. At some future date, a definitive union catalog of Chinese collections will have to be prepared by able scholars blessed with the time and support commensurate with the undertaking.

This preliminary list is intended, therefore, to be an interim research aid. It has been prepared by competent professional librarians with the advice of scholars in the field of Chinese law. It has been supported by the Sub-Committee on Chinese Law of the Joint Committee on Contemporary China, which is sponsored by the American Council of Learned Societies, and by the Harvard Law School, whose personnel carried the task to completion.

Each participating library provided a microfilm copy of its shelf list files for topics chosen from the classification schedule for Chinese materials prepared by Dr. A. K. Chiu. Since most of the films were made in the summer of 1966, the library holdings will generally include publications appearing in the spring of 1966 or earlier. A subject structure was developed paralleling that used in the Harvard Law School Library publication, Annual Legal Bibliography. The card produced from the microfilms were arranged according to those subjects and consolidated so that only one card for each title remained in the file. The Union List symbols for the libraries holding each title were inscribed on that single card, which was then mounted on a page for photo-offset reproduction. It should also be noted that the list contains both historical and contemporary titles, the latter including works from and relating to both the Republic of China and the People's Republic of China.

The Preliminary Union List has four sections. The first, and main, portion of the publication provides for the subject approach to the contents of the participating libraries. The subject headings are in alphabetical order, with cross references included. Under each subject, the items are in alphabetical order again, by author or by title in the absence of an author.

Part two is an alphabetical list of the titles of legal periodicals. Legislative materials - official or unofficial, annotated or unannotated, and translations into languages other than Chinese - are in the third section. The general statutes and compilations appear first, followed by those enactments related only to a particular topic in a subject order identical with the arrangement in the first part.

The last section contains the references to publications in the Chinese language that deal with the law of jurisdictions other than China. Chinese translations of foreign books and Chinese publications on foreign law are included in this fourth section.

Appreciation must be expressed to the libraries that so willingly joined in this effort. Some expressed reservations about the completeness and the quality of the records that they were asked to submit in accordance with criteria that were necessarily imprecise. Yet each recognized the need to provide bibliographic data where none previously existed and the importance of not being inhibited by too great a concern for the appearance of a record. It should be particularly noted that an uncataloged collection is also included; an asterisk (*) precedes the symbol for the University of Washington Law Library to identify uncataloged titles held by the Far Eastern Library of that institution.

The staff responsible for the sorting, arranging and preparation of copy for the printer worked under the pressure of time, which thwarted their desire to engage in the editorial exactness that a preliminary union list of this type necessarily lacks. Mrs. Charlotte Yang, Miss Athena Yuan, Mrs. Kay Kinoshita and Miss Marcia Murphy were patient, understanding and effective in meeting a difficult task.
